**ENGAGING PRIMARY CARE MEDICAL PROVIDERS IN CHILDREN'S ORAL HEALTH**

This policy statement supports the use of fluoride varnish—beginning with tooth eruption—for individuals at moderate to high risk for tooth decay, as an effective adjunct in programs designed to reduce lifetime dental caries experience. Topics include the impact of dental caries on health over the life span, dental caries control, systemic and topical fluoride methods, caries reduction attributable to fluoride varnish, caries risk assessment, and fluoride varnish safety and efficacy.

Topics include community-based and community-wide disease prevention, financial barriers, care-delivery system (work force, safety-net programs, and primary care and other health professionals), public awareness, individuals with special health care needs, diversity and cultural competence, and partnership. Two appendices provide a summary of the regional meetings that describes the dominant themes and comments made by attendees, as well as presentations.
