SBA ELECTIONS DELAYED

Several students requested that the SBA elections be delayed. As a result, the date for submitting nominations has been moved to Wednesday, April 27 at 3 p.m. The election will be held Tuesday, May 3, and a runoff, if necessary, will be held on Thursday, May 5. The Bylaws and election code have been interpreted to require instatement of the new officers on May 9.

TWO PERSONS RUNNING JOINTLY FOR SAME OFFICE

The question was asked whether two persons could jointly run for the same SBA office, on the theory that one would go on a quarter away and wished to guarantee their successor. In previous years joint candidacy was not allowed. This year, the SBA unanimously voted to amend the bylaws on a trial basis to allow joint candidates with the following provisions: no more than two persons can jointly run for a single office, one person must designate the primary candidate who will hold office; the other person will hold office if and only if the primary officeholder leaves for a quarter away.

GSA ELECTIONS

GSA elections will be held on May 4 & 5, with final elections held on May 11 & 12. Petitions for persons running for office were due last Friday. One item on the ballot is a new GSA constitution, written by a splinter group of GSA members without input from many segments of the graduate student population. Though GSA does not work well now, one should not assume that any change will make it better. I will post a copy of the proposed constitution on the SBA bulletin board and if I have time will post my comments for anyone who might be interested. Also on the ballot will be a referendum on the Sports/ Rec center.
