# Preventing acute neurotoxicity of CNS therapeutic oligonucleotides with the addition of $\text{Ca}^{2+}$ and $\text{Mg}^{2+}$ in the formulation

**Oligonucleotide therapeutics (ASOs and siRNAs) have been explored for modulation of gene expression in the central nervous system (CNS), with several drugs approved and many in clinical evaluation. Administration of highly concentrated oligonucleotides to the CNS can induce acute neurotoxicity. We demonstrate that delivery of concentrated oligonucleotides to the CSF in awake mice induces acute toxicity, observable within seconds of injection. Electroencephalography and electromyography in awake mice demonstrated seizures. Using ion chromatography, we show that siRNAs can tightly bind  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  up to molar equivalents of the phosphodiester/phosphorothioate bonds independently of the structure or phosphorothioate content. Optimization of the formulation by adding high concentrations (above biological levels) of divalent cations ( $\text{Ca}^{2+}$  alone,  $\text{Mg}^{2+}$  alone, or  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$ ) prevents seizures with no impact on the distribution or efficacy of the oligonucleotide. The data here establish the importance of adding  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  to the formulation for the safety of CNS administration of therapeutic oligonucleotides.**

## INTRODUCTION

Oligonucleotide therapeutics is a class of drugs with significant potential for developing disease-modifying treatments. To date, there are 18 approved oligonucleotide therapeutics<sup>1</sup>; these include antisense oligonucleotides (ASOs), splice-switching oligonucleotides (SSOs), aptamers, steric blocking (blockmers), gapmers (DNA ASOs with RNA-like segments on both ends), and small interfering RNAs (siRNAs).<sup>2</sup> Therapeutic oligonucleotides can be used to mediate gene expression in the central nervous system (CNS), and several ASOs<sup>3–5</sup> and SSOs are approved for such use.<sup>6,7</sup> While ASOs have been clinically evaluated for decades,<sup>8,9</sup> several chemical configurations of siRNAs, including C16 conjugates<sup>10,11</sup> and divalent,<sup>12,13</sup> have recently demonstrated wide distribution and long-term efficacy in rodents, sheep, and NHP brains.

The safety of ASOs in CNS is highly affected by sequence and modification pattern; safety also differs significantly between blockmers and gapmers, such as Nusinersen and Tofersen, respectively.<sup>14</sup> SSOs have a broad safety profile in the CNS, whereas gapmers have shown variable tolerance *in vivo* with one compound (Tofersen)<sup>4,5,15</sup> approved. Short-term neurotoxicity of ASOs upon CNS administration in mice has been reported, and changes in calcium oscillation correlate to the degree of toxicity.<sup>16</sup> The observed toxicity can be sequence dependent, specifically linking G-rich regions to the phenomena.<sup>17</sup> Combining *in silico* and experimental screening can predict toxicity and minimize the advancement of highly toxic compounds *in vivo*.<sup>17</sup> All clinically qualified gapmer ASOs have a phosphodiester (PO)/phosphorothioate (PS) mixed backbone<sup>6,18,19</sup> because minimizing the backbone PS content is essential for increased tolerability.<sup>20</sup>

Oligonucleotides are short nucleic acids in which the PO or PS groups form the sugar-phosphate backbone of the nucleotide chain. Each sugar-phosphate backbone carries a negative charge at physiological pH, resulting in highly polar negative molecules. In solution, DNA and RNA molecules preferentially bind to divalent cations,<sup>21–23</sup> such as  $\text{Mg}^{2+}$  and  $\text{Ca}^{2+}$ , due to strong electrostatic interactions with negatively charged groups. Tightly bound divalent cations have been reported in many crystal structures and are necessary for forming active sites.<sup>24,25</sup> For therapeutic oligonucleotides, phosphate-buffered saline (PBS) or artificial CSF (aCSF, a buffer closely representing biological CSF composition) is conventionally used for administration. Despite this, no systematic studies have been performed to optimize the

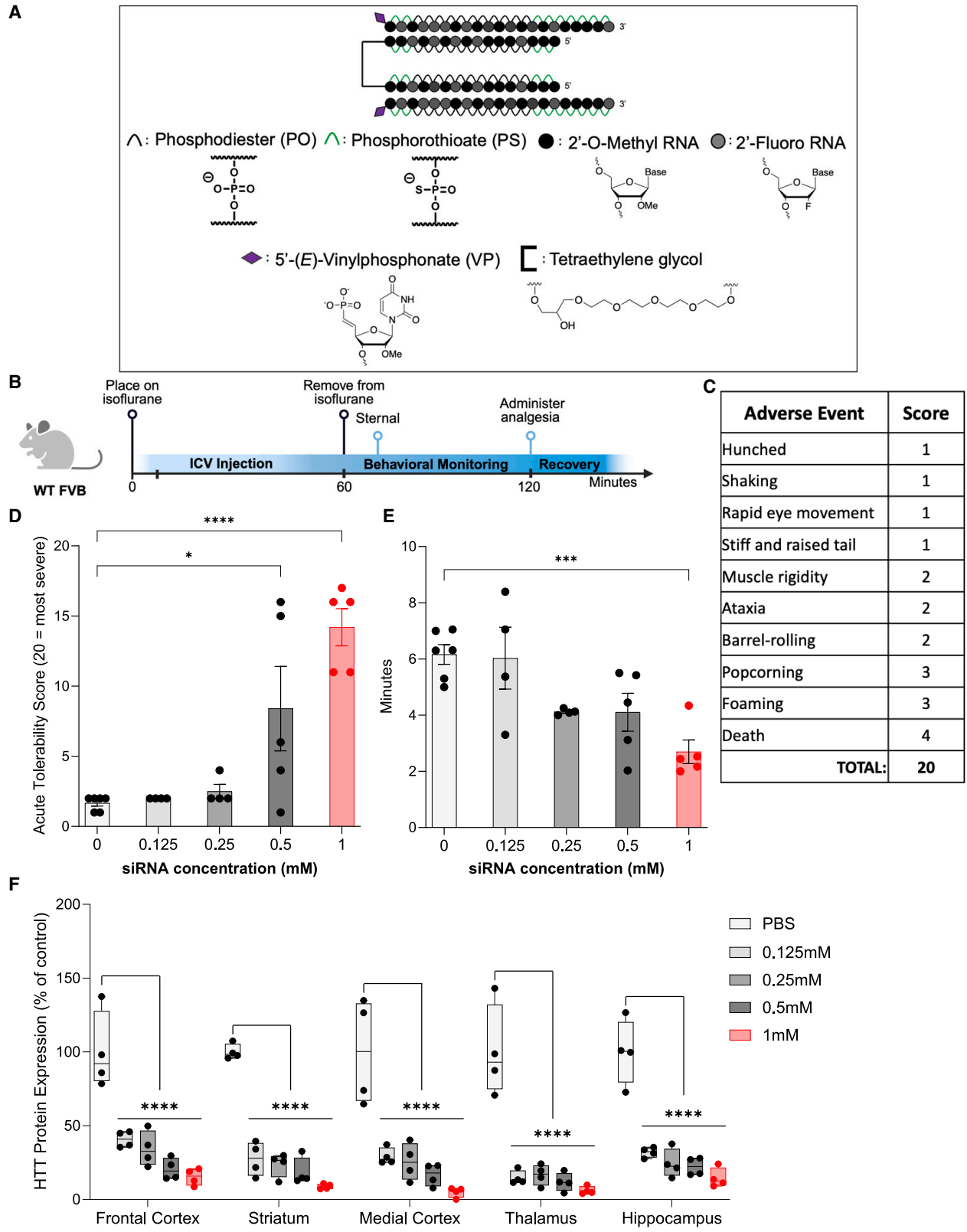

formulation of oligonucleotides, a different class of molecules for RNA interference (RNAi) with distinct chemical features. Thus, optimizing oligonucleotide formulation for safe and efficient delivery to the CNS is necessary.<sup>26–28</sup> We hypothesized that introducing oligonucleotides built on a negatively charged backbone into the CNS could cause neurotoxicity by binding divalent cations from the CSF or intracellular stores.

In this study, we use Huntington's disease (HD) as a model for oligonucleotide-induced toxicity in the CNS. HD is a neurodegenerative disorder caused by a CAG trinucleotide-repeat expansion in exon 1 of the huntingtin (*Htt*) gene. HD has been extensively explored as a target in oligonucleotide therapeutics, with multiple validated and optimized siRNAs and ASOs available.<sup>29–33</sup> The ASO targeting *Htt* (Tominersen) failed in a human phase III trial due to toxicity, represented by increased neurofilament light and ventricular volume.<sup>6,19</sup> Thus, the study of the toxicity of therapeutic oligonucleotides for HD is a reasonable approach to finding safe treatments for a devastating disease that has substantial unmet medical needs.

We demonstrate that di-siRNA targeting *Htt* induces acute abnormal behaviors upon administration of high doses in awake and isoflurane-anesthetized animals. We identified the observed abnormal behaviors as seizures using electroencephalography (EEG) and electromyography (EMG) in awake mice. We demonstrate that adding high amounts of Ca<sup>2+</sup> and Mg<sup>2+</sup> divalent cations to aCSF (~10× of natural levels)<sup>34</sup> prevents acute neurotoxicity and does not affect messenger RNA (mRNA) and protein silencing in wild-type and HD animal models. Thus, optimization of oligonucleotide formulation for CSF administration represents a promising approach for enhancing the safety of this new class of drugs.

## RESULTS

### CNS injections of divalent siRNA induce dose-dependent acute neurotoxicity, measurable by electrophysiology

In the previously published *in vivo* mouse studies, divalent siRNA (di-siRNA) was delivered to the CNS using tribromoethanol (TBE, Avertin) as an anesthetic.<sup>12</sup> This non-pharmaceutical-grade injectable anesthetic deeply anesthetizes the mice for 60–90 min.<sup>14</sup> Due to the

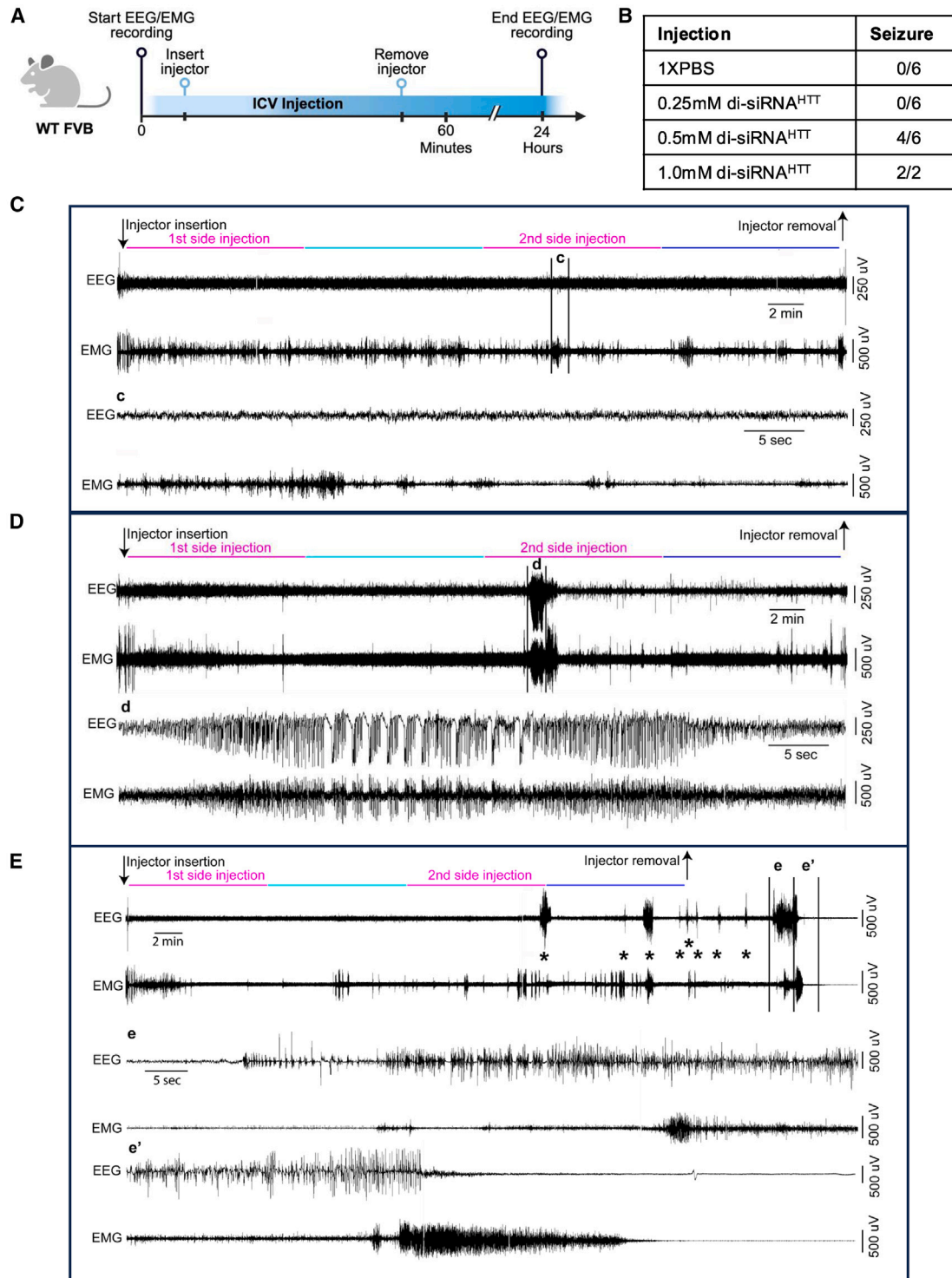
extended period of anesthesia, acute abnormal behaviors that occurred following intracerebroventricular (i.c.v.) di-siRNA administration were not recognizable. In these studies, animals wake up without severe adverse events, and robust mRNA and protein silencing is observed.<sup>12,35,36</sup> Transitioning to the use of isoflurane flow as the anesthesia method for i.c.v. injections revealed acute unfavorable behaviors, including seizures.

To understand the siRNA-induced acute neurotoxicity revealed when using isoflurane, we screened multiple doses of previously published di-siRNA<sup>HTT</sup><sup>12</sup> (Figure 1A) targeting the mRNA of huntingtin (*Htt*). Wild-type FVB mice were used for these studies to eliminate the potential of confounding variables in neurotoxicity readouts with disease models. The mice were anesthetized under isoflurane, injected i.c.v. into both lateral ventricles, and monitored for up to an hour during recovery (Figure 1B). We developed an acute tolerability score to track specific observable abnormal behaviors following di-siRNA delivery into the CSF, which may not represent the typical tonic-clonic seizure (Figure 1C). Abnormal behaviors were scored based on a severity index (1 = least, 4 = most), similar to previous studies reported.<sup>16,17</sup> The least-severe behaviors, including shaking, hunched posture, stiff tail, and rapid eye movement, were assigned 1 point, full body muscle rigidity, ataxia, and barrel-rolling were assigned 2 points, and popcorning and foaming at the mouth were assigned 3 points toward severity. The most severe behavior that could occur within the 1-h monitoring period was death, which was classified as 4 points toward severity. A total score of 20 represents the worst seizure severity observed during recovery, and 0 represents no observed seizures or other adverse events. The average acute tolerability scores for all animals are shown in Table S2.

i.c.v. administration of di-siRNA<sup>HTT</sup> at 0.125, 0.25, 0.5, and 1 mM (~28, ~56, 112.5, and 225 µg) resuspended in 10 µL of 1× Dulbecco's PBS (–/– Ca<sup>2+</sup>/Mg<sup>2+</sup>), referred to as 1× PBS going forward, revealed a dose-dependent neurotoxic readout. Mice injected with 0.125 and 0.25 mM di-siRNA<sup>HTT</sup> had no further observable adverse events compared with the 1× PBS vehicle control mice (Figure 1D). Mice injected with the vehicle control typically exhibited mild phenotypes, predominantly shaking and hunched posture. This was similar for mice injected with 0.125 and 0.25 mM di-siRNA<sup>HTT</sup>. Following

administration of 0.5 and 1 mM di-siRNA<sup>HTT</sup> injections, the severity of adverse events increased substantially, resulting in death for some animals at the maximum dose tested (Figure 1D). Video recordings documented these findings (Video S1). The mice injected with 0.5 mM di-siRNA<sup>HTT</sup> took significantly less time to right themselves and be sternal after being removed from isoflurane compared with the vehicle controls (Figure 1E). Higher doses of di-siRNA<sup>HTT</sup> are necessary to reach >50% silencing of HTT protein.<sup>12</sup> HTT protein levels were measured 1 month following di-siRNA<sup>HTT</sup> administration to confirm the dose-dependent effects (Figure 1F). The 1 mM (225 µg/10 µL) di-siRNA<sup>HTT</sup> delivered i.c.v. provided maximum protein silencing (85%–95% reduction across the brain) and, based on these data, we chose to optimize the formulation of di-siRNA<sup>HTT</sup> at the 1 mM concentration and inject 225 µg/10 µL for these studies.

To test if the seizure-like behaviors described above are due to an interaction with the anesthetic or the oligonucleotide alone, *in vivo* electroencephalography (EEG) and electromyography (EMG) were monitored during and after i.c.v. di-siRNA<sup>HTT</sup> injections in awake mice (Figure 1A). Wild-type mice were surgically implanted with EEG/EMG electrodes and a bilateral guide cannula targeting the lateral ventricles<sup>37–41</sup> (details in materials and methods). Following post-surgery recovery and an adaptation period to the recording conditions, awake mice were injected with di-siRNA<sup>HTT</sup>, and EEG/EMG was simultaneously recorded (Figure 2A). Using SleepSign for Animal software (Kissei Comtec, Japan) assisted by spectral analysis using fast Fourier transform (FFT), polygraphic records were visually inspected offline for high-amplitude EEG/EMG waves characteristic of seizures.<sup>37–40</sup> Seizures were defined as periods with high frequency and high amplitude with a minimum duration of 5 s. Seizures were identified visually from EEG/EMG signals, and videos were checked to determine if there was a behavioral accompaniment. Mice injected i.c.v. with 10 µL 1× PBS as a control injection had no adverse events related to the injection and displayed typical EEG/EMG recordings throughout (Figure 2C). Representative EEG/EMG traces from a control mouse receiving an i.c.v. injection of 1× PBS control showed no high-amplitude waves, indicating no seizures in response to the i.c.v. injection (Figure 2C).

The acute tolerability of di-siRNA<sup>HTT</sup> was evaluated with a dose response of 0.25 mM (~56 µg), 0.5 mM (112.5 µg), and 1 mM (225 µg) resuspended and injected in 10 µL of 1× PBS into both lateral ventricles (Figure 2B). Mice injected with 0.25 mM

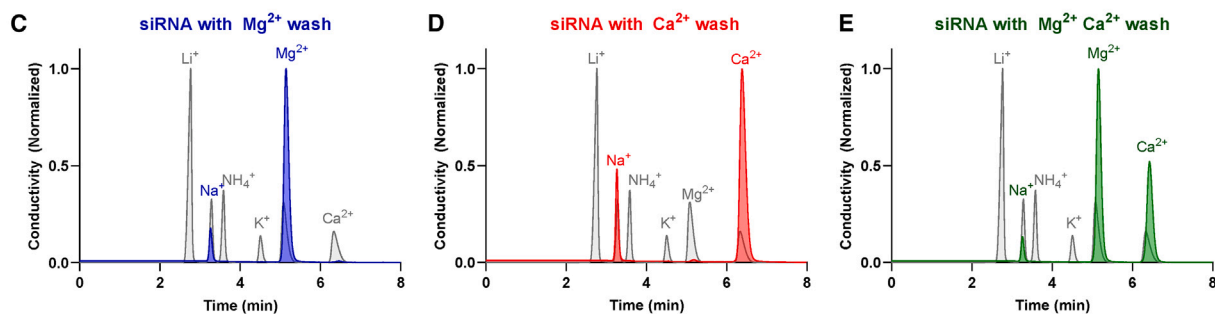
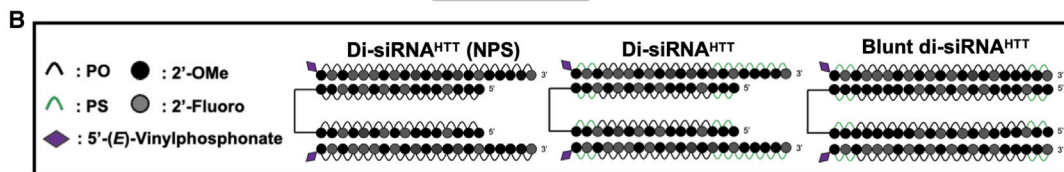
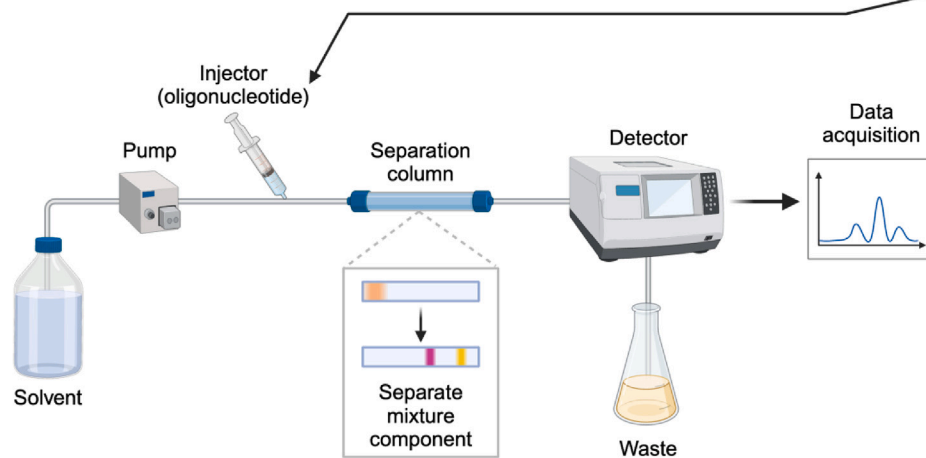
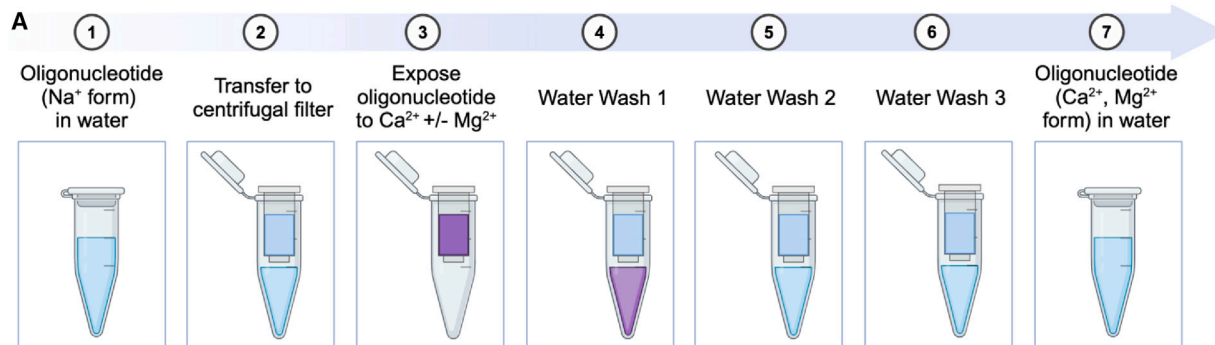
(~56 µg/10 µL) di-siRNA<sup>HTT</sup> in 1× PBS had no observable effects and displayed EEG/EMG recordings similar to controls. Reaching higher di-siRNA<sup>HTT</sup> concentrations of 0.5 mM (112.5 µg/10 µL) elicited seizures in four out of six mice total, as recorded by EEG/EMG (Figure 2D, d). Representative EEG/EMG traces show striking differences between those from mice with normal phenotypes and those with tonic-clonic seizures (Figures 2C–2E). Two mice injected with 1 mM (225 µg/10 µL) di-siRNA<sup>HTT</sup> in 1× PBS died after displaying multiple seizures, characterized by high-amplitude EEG waves and intense EMG activity that started during the injection period. About 10 min following the removal of the injector, the mice entered a prolonged seizure (e, e') that resulted in death, characterized by the absence of an EEG/EMG signal. Following a minimum of 24 h of recording after the i.c.v. injection, mice were deeply anesthetized (ketamine/xylazine, 200/20 mg/kg, intraperitoneal [i.p.]) and received bilateral i.c.v. injections of blue dye (0.5 µL per side). The brains were extracted and sectioned (antero-posterior axis, mid-line). Only data from brains showing dye evenly distributed throughout the CSF stores were included in the study (Figure S2). Video recordings were saved throughout the electrophysiology recording periods so overt behavioral phenotypes could be paired with adverse events recorded on EEG/EMG. These studies were invaluable for confirming the neurotoxic behavioral phenotypes observed following i.c.v. injections in mice.

#### Oligonucleotides can preferentially bind Ca<sup>2+</sup> and Mg<sup>2+</sup> divalent cations in an equimolar ratio to the PO/PS backbone *in vitro*

*In vitro*, we demonstrate that oligonucleotides can bind Ca<sup>2+</sup> and Mg<sup>2+</sup> divalent cations and retain these ions upon multiple water washes (Figure 3). We used ion chromatography to gain insight into the binding capacity of cations to oligonucleotides (Figure 3A). In the sodium form following synthesis, di-siRNA<sup>HTT</sup> with and without PS backbone modifications and a blunt version of di-siRNA<sup>HTT</sup> (Figure 3B) were exposed to 100 mM Ca<sup>2+</sup>, 100 mM Mg<sup>2+</sup>, or 100 mM Ca<sup>2+</sup>/Mg<sup>2+</sup> solutions, then washed three times with sterile nuclease-free water and run on ion chromatography (Figure 3B). Representative chromatograph traces of the ion chromatography are displayed (Figures 3C–3E). The standard traces are in gray, Mg<sup>2+</sup> in blue (Figure 3C), Ca<sup>2+</sup> in red (Figure 3D), and Ca<sup>2+</sup>/Mg<sup>2+</sup> in green (Figure 3E). The separation of the cations is based on the size and charge of the ions interacting with the stationary phase of the column and the mobile phase. Changes in electrical conductivity are measured as peaks when the separated ions reach the detector, and the areas under the curves are relative to the specific cation

guide cannula. The compounds were first injected in one of the two lateral ventricles and then in the second lateral ventricle (5 µL in 10 min, pink lines). concentrations compared with the standards. The results of the analysis are shown in Figure 3F.

There was an approximately 1:1 ratio of the measured cations bound to phosphates (PO and PS) in the oligonucleotide backbone for every di-siRNA and cation exposure condition tested (Figure 3F). This may indicate high-affinity interactions, where 1 mol of the di-siRNA<sup>H<sub>TT</sub></sup> can bind up to 74 mol of cations to keep the charge neutrality of the solution (Figure S3). When di-siRNA<sup>H<sub>TT</sub></sup> was exposed to only Ca<sup>2+</sup>, the Ca<sup>2+</sup> to Na<sup>+</sup> ratio was approximately 3:1, suggesting that Ca<sup>2+</sup> binds to phosphates 3× greater than monovalent Na<sup>+</sup> cations (Figure 3F). When di-siRNA<sup>H<sub>TT</sub></sup> was exposed to only Mg<sup>2+</sup>, the Mg<sup>2+</sup> to Na<sup>+</sup> ratio was approximately 6:1 (Figure 3F). This suggests that Mg<sup>2+</sup> has a 6× greater binding affinity to phosphates than Na<sup>+</sup> and 2× greater binding affinity than Ca<sup>2+</sup>. At our saturation conditions, there was no detectable difference in binding capacity between PO and PS bonds (Figure 3F). A blunt-ended di-siRNA<sup>H<sub>TT</sub></sup> was also tested following exposure to 100 mM Ca<sup>2+</sup>/Mg<sup>2+</sup> to determine whether the molecule's structure impacted the binding capacity of the divalent cations (Figure 3D). The blunt-di-siRNA<sup>H<sub>TT</sub></sup> contains ten more phosphates than the di-siRNA<sup>H<sub>TT</sub></sup>, which sequestered more cations in total but maintained the same approximate 1:1 ratio of backbone phosphates to cations. These data provide insight into the capacity of divalent cations to bind to oligonucleotides *in vitro*, which aids in the exploration of oligonucleotide-induced neurotoxicity and prevention.

### Adding Ca<sup>2+</sup> and Mg<sup>2+</sup> to aCSF mitigates acute neurotoxic behavioral phenotypes in a concentration-dependent manner

Here, we systematically evaluate if adding Ca<sup>2+</sup> and Mg<sup>2+</sup> to the formulation can eliminate acute neurotoxicity. Since Ca<sup>2+</sup> phosphate salts have low solubility, mixing Ca<sup>2+</sup> into the PBS buffer, specifically over time, results in the formation of micro-precipitates, which are severely toxic upon CSF administration.<sup>20</sup> Due to this, a novel HEPES-based aCSF composition was used as a diluent. The final concentrations of the aCSF components are 137 mM NaCl, 5 mM KCl, 20 mM D-(+)-glucose, and 8 mM HEPES, with a final pH of 7.4. Natural CSF contains ~3.0 mM Ca<sup>2+</sup> and ~1.3 mM Mg<sup>2+</sup> levels in humans.<sup>34,42,43</sup> Commercial aCSF (Elliott's B solution; NDC 55792-007)<sup>44</sup> contains 1.35 mM Ca<sup>2+</sup> and 1.2 mM Mg<sup>2+</sup>.<sup>45</sup> The 1 mM (225 µg/10 µL dose) di-siRNA<sup>H<sub>TT</sub></sup> (typical for i.c.v. injection) (Figure 4A) has 74 mM of negatively charged backbone. Theoretically, the oligonucleotide can bind 74 divalent cations equivalents, far exceeding ~2.2 mM Ca<sup>2+</sup>/Mg<sup>2+</sup> CSF levels in humans. Serial dilutions

of Ca<sup>2+</sup> and Mg<sup>2+</sup> were made in the diluent aCSF (containing no Ca<sup>2+</sup> and Mg<sup>2+</sup>) to make a range of divalent cation-enriched aCSF solutions. The stocks were later combined to create various ratios of Ca<sup>2+</sup> and Mg<sup>2+</sup> in aCSF.

The acute neurotoxicity was evaluated with an escalation of Ca<sup>2+</sup> concentration in aCSF buffer while maintaining the same 1 mM (225 µg/10 µL total injected dose) di-siRNA<sup>H<sub>TT</sub></sup> in wild-type mice (Figure 4B). Increasing the Ca<sup>2+</sup> concentration incrementally from 0 to 16 mM in aCSF buffer reduced the severity of seizures in a dose-dependent manner ( $n = 4-6$ ) (Figure 4C). The 1 mM di-siRNA<sup>H<sub>TT</sub></sup> (225 µg/10 µL total injected dose) required 16 mM Ca<sup>2+</sup> in aCSF buffer to significantly reduce abnormal behaviors. Mice injected with excess Ca<sup>2+</sup> (32 mM in aCSF) did not have seizures but had prolonged recovery and sternal times (Figure S4A). We also tested a 16 mM Ca<sup>2+</sup> aCSF control with no siRNA to see if this amount of Ca<sup>2+</sup> alone would be toxic. We found that injecting an excess of Ca<sup>2+</sup> with no negatively charged siRNA resulted in prolonged sternal times but not seizures for some animals (Figure S4A). These data underlie the importance of having an exact ratio of Ca<sup>2+</sup> to oligonucleotide in the injected compound to prevent neurotoxicity.

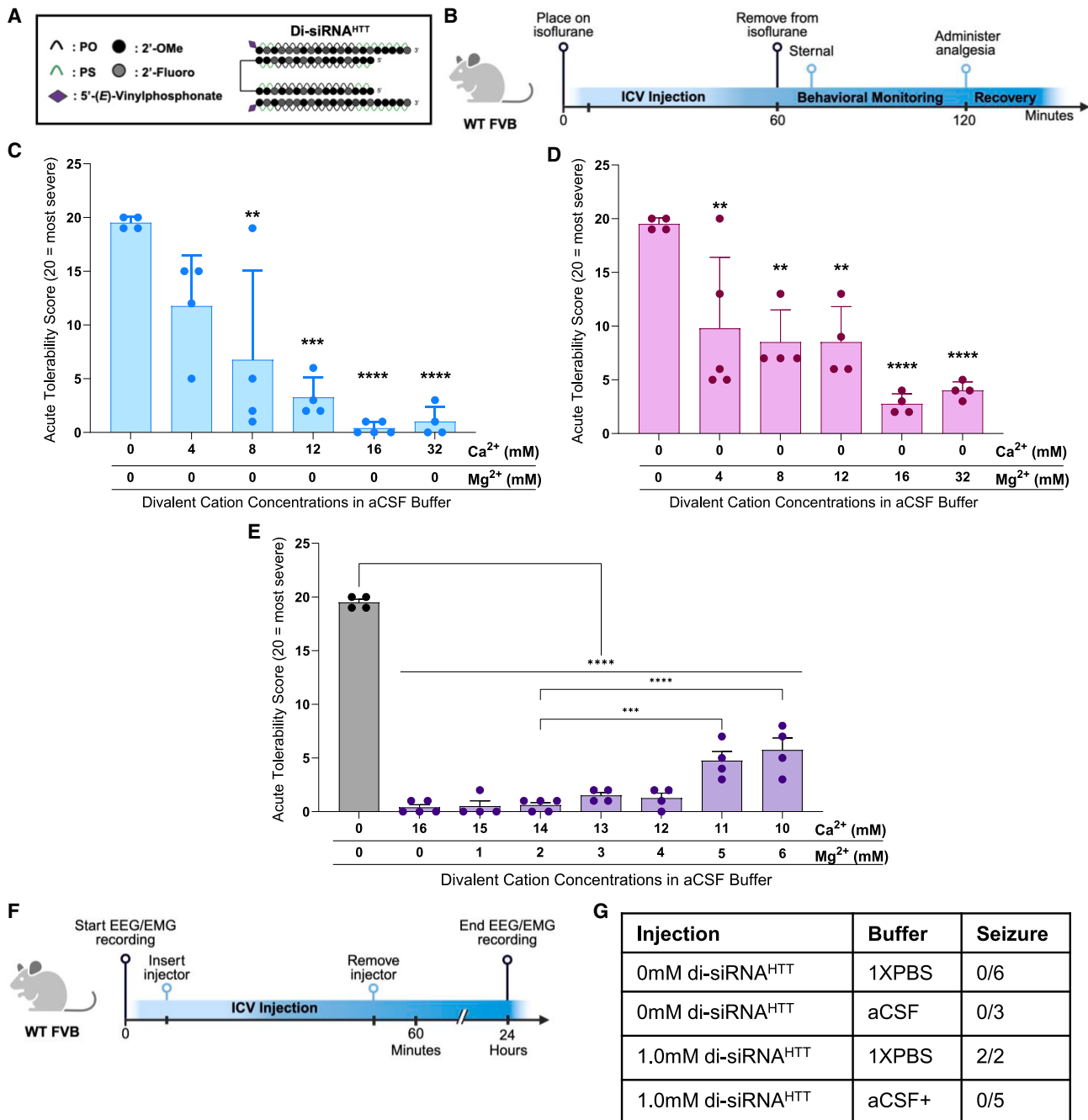
Due to the slight differences in binding capacities of Mg<sup>2+</sup> and Ca<sup>2+</sup> to the di-siRNA, we next evaluated the effect of adding Mg<sup>2+</sup> into aCSF buffer while maintaining the same 1 mM (225 µg/10 µL total injected dose) di-siRNA<sup>H<sub>TT</sub></sup>. Similar to the Ca<sup>2+</sup> titration in aCSF buffer, increasing the Mg<sup>2+</sup> concentration from 0 to 16 mM in aCSF buffer reduced the seizure phenotypes in a dose-dependent manner (Figure 4D). The same concentration of Mg<sup>2+</sup> was required to improve the acute tolerability compared with the di-siRNA<sup>H<sub>TT</sub></sup> delivered with Ca<sup>2+</sup> in aCSF. Mice injected with excess Mg<sup>2+</sup> (32 mM in aCSF) had hyperactive phenotypes for approximately 1 h following i.c.v. injections. There was no difference in the time it took the mice to be sternal when injected with excess Mg<sup>2+</sup> in aCSF compared with 1× PBS vehicle controls (Figure S4B).

To reach the necessary concentrations of divalent cations in aCSF and prevent delivering excess Ca<sup>2+</sup> or Mg<sup>2+</sup>, we proposed that a combination of the two in aCSF may be the safest formulation. We screened 1 mM (225 µg/10 µL total injected dose) di-siRNA<sup>H<sub>TT</sub></sup> formulated in aCSF buffer with increasing Mg<sup>2+</sup> concentrations while reducing the Ca<sup>2+</sup> concentration (Figure 4E). A range of aCSF buffers containing a concentration of 16 mM total divalent cations were prepped with differing Ca<sup>2+</sup> and Mg<sup>2+</sup> ratios. The buffer concentrations

screened were 16:0, 15:1, 14:2, 13:3, 12:4, 11:5, and 10:6,  $\text{Ca}^{2+}/\text{Mg}^{2+}$ , respectively. Increasing the  $\text{Mg}^{2+}$  and decreasing the  $\text{Ca}^{2+}$  concentration was tolerated with 15:1 and 14:2 ratios of  $\text{Ca}^{2+}/\text{Mg}^{2+}$  in aCSF (Figure 4E). Moving the  $\text{Ca}^{2+}/\text{Mg}^{2+}$  ratio in aCSF to 13:3 and 12:4 was also tolerated, but mice experienced mild adverse events (shaking, hunched posture, and ataxia). Increasing the  $\text{Mg}^{2+}$  and decreasing the  $\text{Ca}^{2+}$  eventually produced observable toxicity (Figure 4E). These studies revealed that an ideal ratio of  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  divalent cations in aCSF to mitigate any adverse events completely was 14:2 (14 mM  $\text{Ca}^{2+}$  and 2 mM  $\text{Mg}^{2+}$ ) ratio for 1 mM di-siRNA<sup>HTT</sup>. Video recordings documented these findings (Video S2). This 14:2 (14 mM  $\text{Ca}^{2+}$  and 2 mM  $\text{Mg}^{2+}$ ) formulation will be referred to as aCSF+.

To confirm the safety of formulating di-siRNA<sup>HTT</sup> in aCSF+ before i.c.v. injections, we studied EEG/EMG in wild-type mice. The same di-siRNA<sup>HTT</sup> (Figure 4A) was injected bilaterally into both lateral ventricles of awake mice to confirm the absence of an acute seizure phenotype by EEG/EMG recording (Figure 4F). As shown previously, i.c.v. injections of 1 mM (225  $\mu\text{g}/10 \mu\text{L}$  total injected dose) di-siRNA<sup>HTT</sup> in 1 $\times$  PBS induced acute seizures (Figure S5A). Injecting 1 mM (225  $\mu\text{g}/10 \mu\text{L}$  total injected dose) di-siRNA<sup>HTT</sup> in aCSF+ did not illicit any seizure activity recorded by EEG/EMG (Figure S5B). Video recordings were also populated throughout the electrophysiology experiments so overt behavioral phenotypes could be paired with adverse events recorded on EEG/EMG. Confirming the absence of spiking activity via electrophysiology is a precise measure of the safety of oligonucleotides delivered to the CNS. It should be considered as a safety readout for preclinical studies.

#### di-siRNA formulated in aCSF+ maintains efficacy and distribution throughout the mouse brain

To evaluate if the formulation of di-siRNA<sup>HTT</sup> in aCSF+ may impact distribution and efficacy, *Htt* mRNA and HTT protein were measured 2 months following i.c.v. injections. There was robust distribution and efficacy with 1 mM (225  $\mu\text{g}/10 \mu\text{L}$  total injected dose) di-siRNA<sup>HTT</sup> formulated in aCSF+. The extent of *Htt* mRNA silencing is lower than HTT protein silencing because  $\sim 50\%$  of the mRNA is localized to the nucleus.<sup>46</sup> As expected, di-siRNA<sup>HTT</sup> formulated in aCSF+ reduced *Htt* mRNA by  $\sim 50\%$  (Figure 5A) and significantly reduced HTT protein expression by  $\sim 90\%$  across all brain regions evaluated (Figures 5B and S6). There was no change in GFAP mRNA levels between di-siRNA<sup>HTT</sup> and vehicle controls (Figure 5C). The aCSF+ formulation developed to deliver oligonucleotides to the CNS safely does not impact the distribution in the brain or efficacy of mRNA and protein lowering.

#### Maintaining the ratio of oligonucleotide to divalent cations in aCSF+ is safe at multiple doses

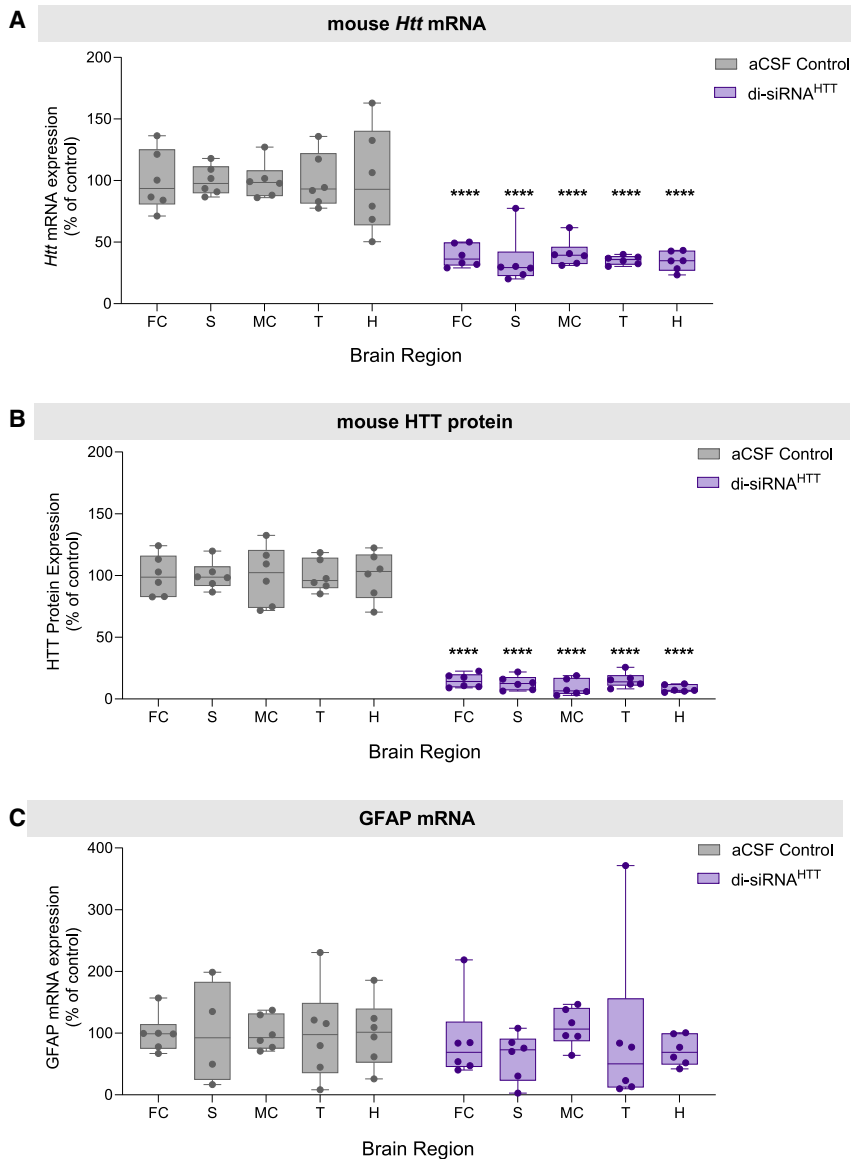
To test if the same aCSF+ buffer would mitigate acute neurotoxicity with higher doses of oligonucleotide, 450  $\mu\text{g}/10 \mu\text{L}$  di-siRNA<sup>HTT</sup> was injected. The same di-siRNA<sup>HTT</sup> described previously (Figure 6A) was formulated in aCSF+ with a 2 mM final concentration. Wild-type mice were injected bilaterally into both ventricles under isoflurane anesthesia and monitored post-operatively (Figure 6B). With a 450  $\mu\text{g}$  (2 mM) di-siRNA<sup>HTT</sup> dose, aCSF+ did not improve the acute tolerability. Doubling the  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  concentrations in aCSF+ to maintain a consistent ratio of di-siRNA<sup>HTT</sup> and divalent cations was necessary to mitigate acute neurotoxicity. Interestingly, the 2 mM (450  $\mu\text{g}/10 \mu\text{L}$  dose) di-siRNA<sup>HTT</sup> in aCSF+ containing only  $\text{Ca}^{2+}$  was not tolerated, whereas aCSF+ enriched with  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  completely mitigated acute neurotoxicity (Figure 6C). This indicated that both  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  may be required in aCSF+ in a consistent ratio to the oligonucleotide concentration in the solution. Safely injecting the maximum deliverable di-siRNA<sup>HTT</sup> dose in mice is an important step forward for CNS oligonucleotide therapeutic development.

#### di-siRNA PS content and structure have minimal impact on the divalent cation formulation necessary to prevent neurotoxicity

Throughout these studies, other variables within the oligonucleotide makeup that may contribute to acute neurotoxicity were considered. The addition of PS modifications to oligonucleotides is commonly used to enhance the stability and duration of effect.<sup>47–49</sup> These are critical factors for their usefulness as therapeutics but come with the disadvantage of increased toxicities.<sup>50–52</sup> To further understand the mechanism of binding between di-siRNA<sup>HTT</sup> and divalent cations in CSF, wild-type mice were injected under isoflurane (Figure 6B) with 1 mM (225  $\mu\text{g}/10 \mu\text{L}$  dose) di-siRNA<sup>HTT</sup> containing no PS content, and the previously described di-siRNA<sup>HTT</sup> containing 26 mM PS in 1 $\times$  PBS or aCSF+ (Figure 6D). The severity of seizures observed was reduced with decreased PS content in di-siRNA<sup>HTT</sup>. The di-siRNA<sup>HTT</sup> with 26 mM PS content induced severe acute adverse events compared with 1 $\times$  PBS vehicle controls (Figure 6E). When the same di-siRNAs were formulated in aCSF+ for i.c.v. injection, nearly complete mitigation of all adverse events was observed (Figure 6E). The significant difference in acute tolerability represents that the oligonucleotide-induced neurotoxicity is not dependent on PS modifications, as seen in the cases of ASOs and hepatotoxicity.<sup>50,51,53</sup>

Since di-siRNAs are only one class of siRNA oligonucleotides in development for treating CNS diseases, we next assessed whether aCSF+ would be safe for other variations of HTT-targeting siRNAs. The di-siRNA<sup>HTT</sup><sup>12</sup> used for most of the studies presented here comprises a dimeric sense strand, or two 16-mer sense strands linked together, each bound to a 21-mer antisense strand targeting *Htt*

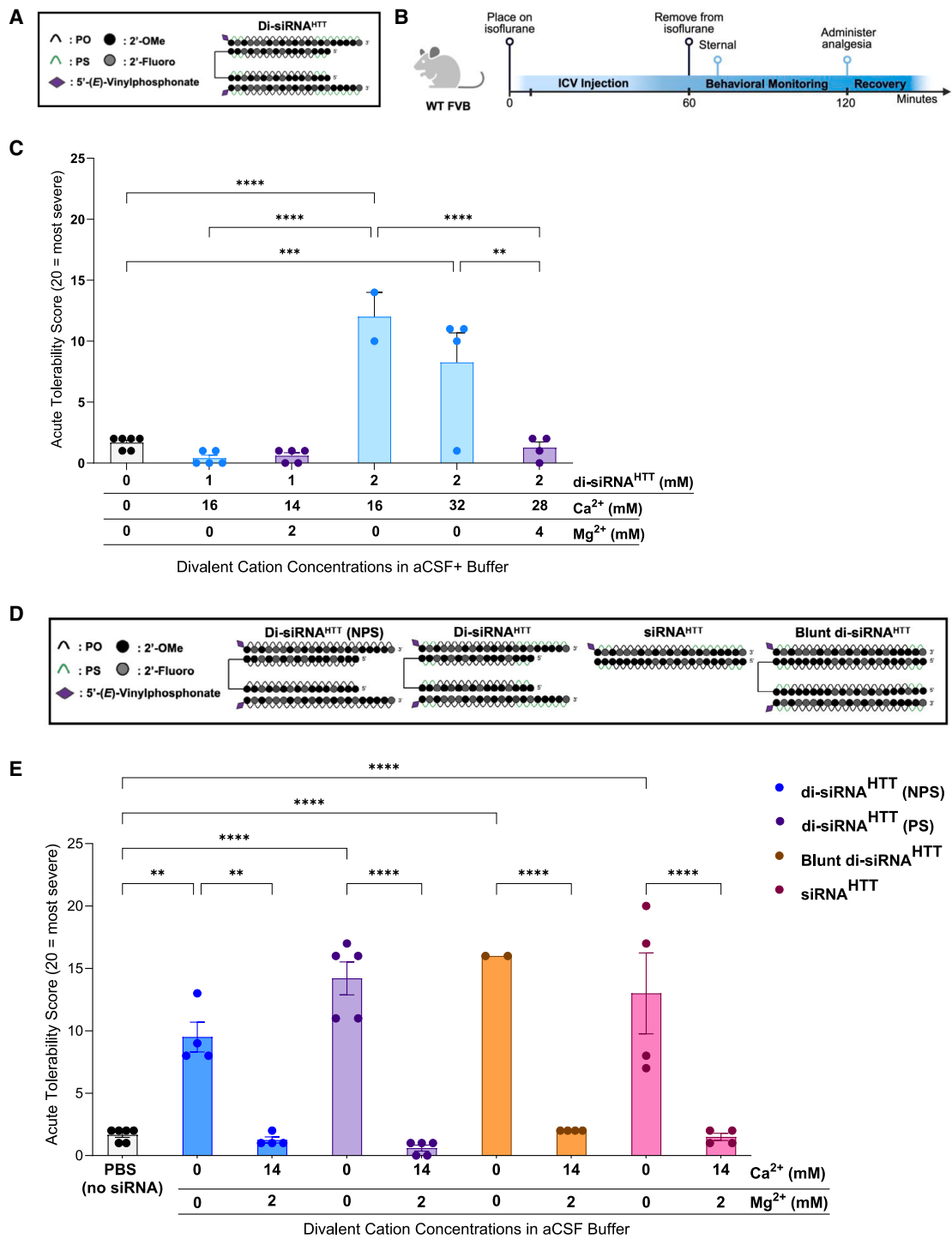
in aCSF+. This may be due to the blunt-ended molecule containing ten more phosphates than the di-siRNA<sup>HTT</sup>, allowing for more binding of divalent cations (Figure 3F), as well as the higher avidity of divalent cations for double-stranded rather than single-stranded RNA.<sup>22,54</sup> Considering the vast differences in the acute neurotoxicity of the blunt-di-siRNA<sup>HTT</sup> delivered in  $1 \times$  PBS versus aCSF+, only two animals were evaluated in these treatment groups. Further evaluation of the  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  concentration in aCSF buffer may be necessary when the total di-siRNA charge is changed to mitigate all adverse events completely during recovery.

#### Using aCSF+ reduces the acute neurotoxicity of CNS-administered ASOs

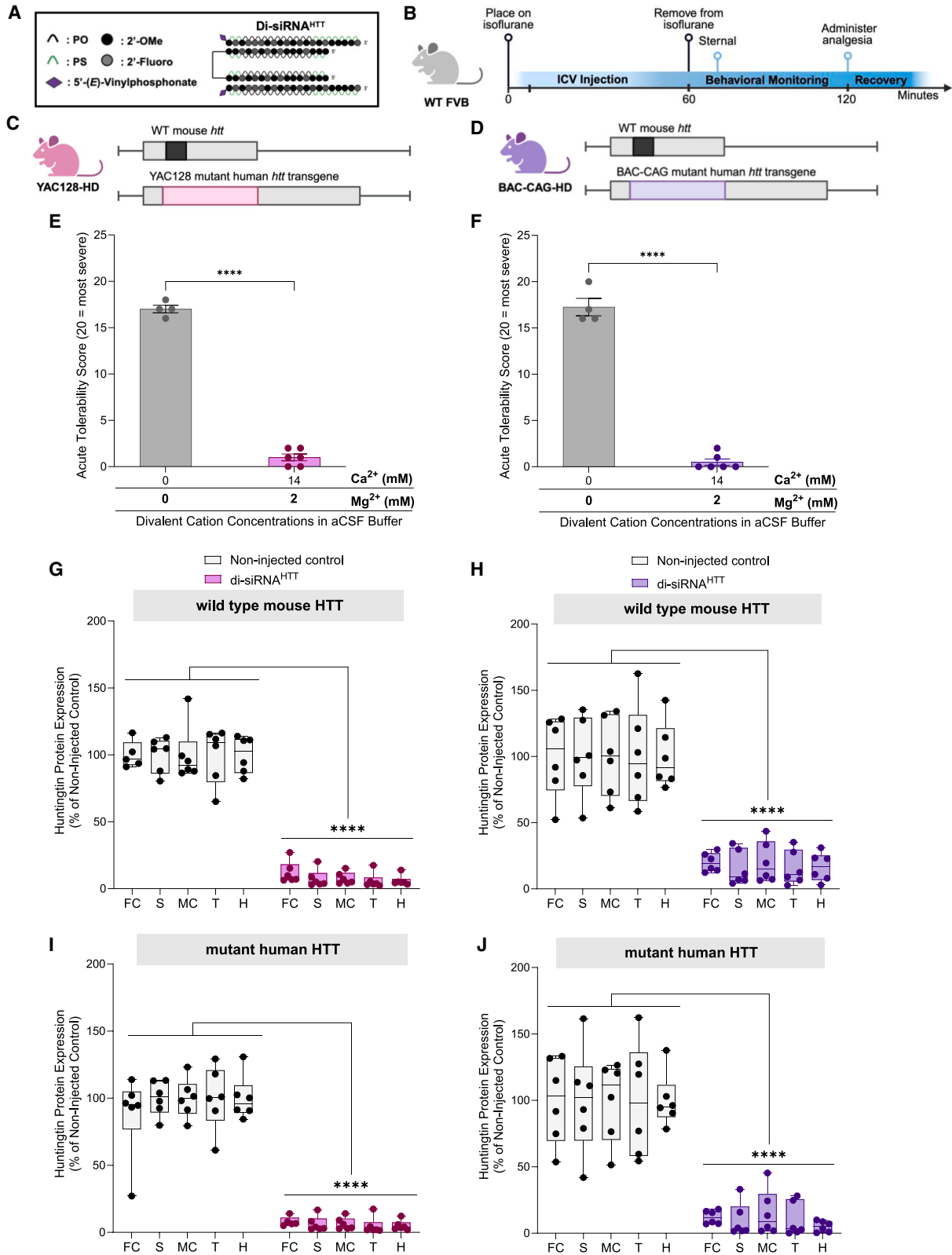
**Figure 7. aCSF+ enables safe delivery for full PS and mixed PO/PS backbone ASOs**

Fully PS ASOs induce severe short-term behavior phenotypes similar to siRNAs. The

reduction in the PS context results in a decrease in the level of observed toxicity while sacrificing long-term stability.<sup>20</sup> The most clinically advanced ASO gapmers utilize a mixed PO/PS backbone. We explored the potential of using the aCSF+ buffer on the safety profile of a full PS and a mixed PO/PS ASO in the CNS of wild-type mice (Figure 7A). Tominersen,<sup>29</sup> one ASO tested here, is a published DNA-MOE gapmer ASO that targets *Htt* to reduce total huntingtin RNA and protein (Figure 7B). Substitution of the six PS backbones in the flank regions to PO significantly decreased the observable acute toxicity, similar to what is reported in a side-by-side comparison by Moazami et al.<sup>20</sup> for C9orf72 targeting antisense. Using the same acute tolerability score described previously (Figure 1C), a comparable dose of 225  $\mu\text{g}/10 \mu\text{L}$  of the full PS and mixed PS/PO ASOs was evaluated in wild-type mice under

mRNA. The longer antisense strand creates an overhang region containing single-stranded nucleic acids, which may influence this neurotoxic seizure response. To assess this, wild-type mice received bilateral i.c.v. injections of 1 mM (225  $\mu\text{g}/10 \mu\text{L}$  dose) HTT-targeting monovalent siRNA or HTT-targeting blunt-di-siRNA<sup>HTT</sup> (Figure 6D). For each siRNA, two mice were injected side by side; one with the oligo resuspended in aCSF+, and the other with the oligo resuspended in  $1 \times$  PBS buffer. The severity of acute neurotoxicity was similar between all four siRNAs injected 1 mM in  $1 \times$  PBS (Figure 6E). Only two animals were injected with the blunt-di-siRNA<sup>HTT</sup> due to death occurring within 10 min following the injection. Formulating all four siRNAs in aCSF+ significantly reduced the acute neurotoxicity and prevented any seizures from occurring (Figure 6E). The blunt-ended di-siRNA<sup>HTT</sup> was slightly less tolerated than the di-siRNA<sup>HTT</sup>

isoflurane (Figure 7A). This dose of ASO has the same PO/PS molar equivalents as the dose used for the previously described siRNA safety evaluations. Mice injected i.c.v. with fully PS-modified ASO showed severe neurotoxic phenotypes with observable seizures for extended periods of time, similar to siRNAs (Figure 7C). The PS/PO mix backbone ASO was significantly better tolerated (Figure 7D) without detectable seizures by EEG/EMG (Figure S7). Instead, the mixed backbone ASO-injected mice consistently display hyperactivity during recovery, and some experienced ataxia. The time it took mice to wake up and right themselves was less influenced by ASO-induced toxicity (Figure S8) than what was seen with the di-siRNA studies (Figures 1E and S4).

We next decided to evaluate the impact of the addition of  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  in aCSF with CSF administration of ASOs. The duplexed (siRNA) and single-stranded (ASO) oligonucleotides differ profoundly in their biophysical properties.<sup>55</sup> The ASO is amphiphilic in nature with hydrophobic bases and a negatively charged backbone. The duplexed part of the siRNA is rigid and negatively charged, with hydrophobic bases hidden inside the duplex. Thus, the optimal concentration of divalent might be different for two classes of oligonucleotides. For this reason, two formulations of aCSF+ were evaluated with 14:2 (14 mM  $\text{Ca}^{2+}$  and 2 mM  $\text{Mg}^{2+}$ ) and 7:1 (7 mM  $\text{Ca}^{2+}$  and 1 mM  $\text{Mg}^{2+}$ ) divalent cations added.

With the fully PS-modified ASO, both aCSF+ formulations increased the short-term tolerability of ASOs in a dose-dependent manner. The higher, 14:2  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  formulation, as selected for the previously described di-siRNA studies, eliminated most acute adverse events during recovery (Figure 7C). For some animals, this formulation resulted in delayed wake-up times. With the 7:1  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$ , some adverse events indicative of seizures were observed but were significantly reduced compared with the 1× PBS ASO delivery (Figure 7C). Thus, optimal ratios of the additional divalent cations in the formulation are likely different depending on the structure of the oligonucleotides.

For the mixed PO/PS backbone ASO, formulating in two different aCSF+ buffers for i.c.v. injections significantly increased the acute tolerability in all mice, with no hyperactivity and ataxia phenotypes detected (Figure 7D). Similar to the full PS variants, longer recovery times were observed with the 14:2  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  formulation, indicating that a non-bound excess of  $\text{Ca}^{2+}$  and  $\text{Mg}^{2+}$  might be problematic.

### The use of aCSF+ mitigates acute neurotoxicity of di-siRNA<sup>HTT</sup> in HD mouse models

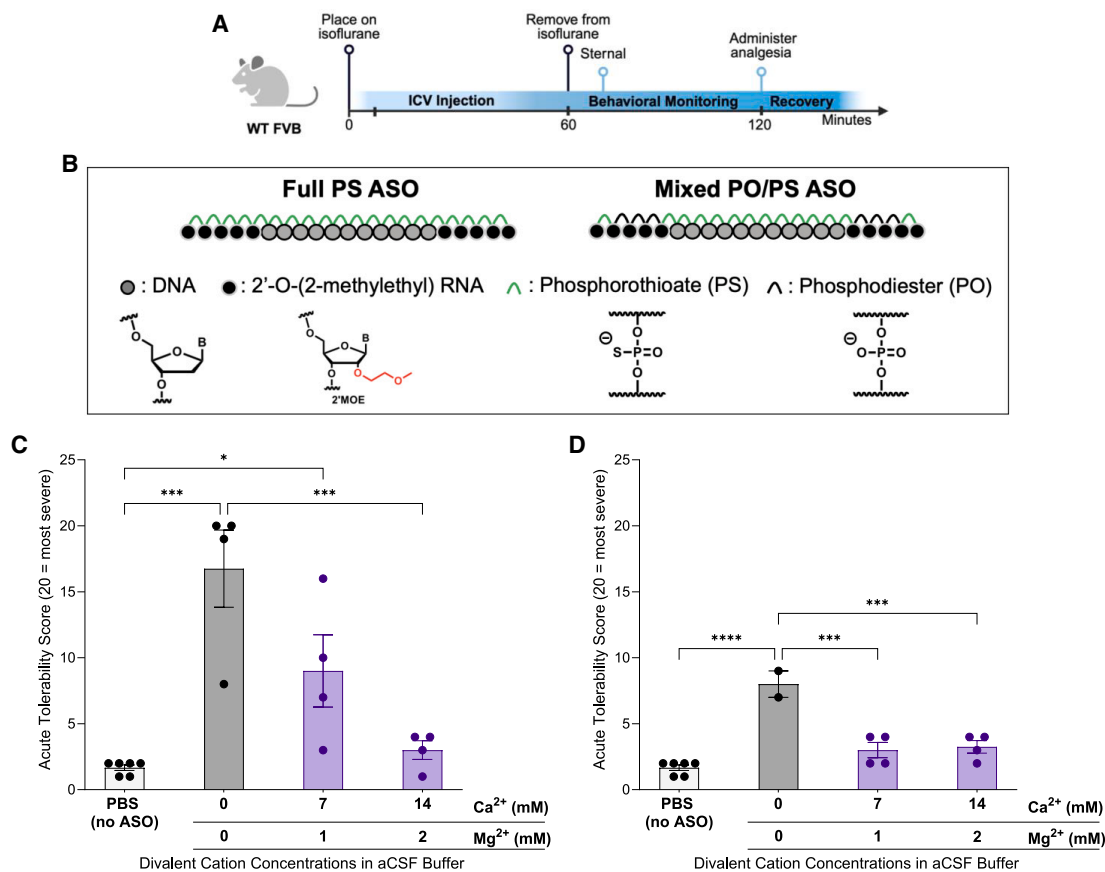
Finally, it was essential to confirm the acute safety of delivering di-siRNA<sup>HTT</sup> (Figure 8A) in aCSF+ in neurodegenerative disease models under isoflurane anesthesia (Figure 8B). Before aCSF+ formulation, 1 mM (225  $\mu\text{g}/10 \mu\text{L}$  dose) di-siRNA<sup>HTT</sup> delivered in 1× PBS to YAC128 HD (Figure 8C) and BAC-CAG HD (Figure 8D) transgenic mice elicited tonic-clonic seizures. With the aCSF+, 1 mM di-siRNA<sup>HTT</sup> was injected bilaterally into both lateral ventricles with no observable neurotoxicity in YAC128 HD mice (Figure 8E) and BAC-CAG HD mice (Figure 8F). Evaluating this delivery formulation in animal models with sporadic seizures may be beneficial to see if this level of divalent cations would enhance or dilute that phenotype. The mice were sacrificed 1 month following injection, and HTT protein levels were measured by ProteinSimple Wes (Figures 8G–8J and S9) to confirm efficacy similar to what was seen in wild-type mice (Figure 5) and previously shown in HD models.<sup>35,36,56</sup> Ensuring the safety of oligonucleotides in animal disease models should be an essential consideration before moving them into clinical trials.

## DISCUSSION

Oligonucleotides (ASOs and siRNAs) have become an increasingly popular therapeutic modality, with the CNS being one of the areas of intense preclinical and clinical development.<sup>57,58</sup> Oligonucleotides do not cross the blood-brain barrier and must be delivered through direct cerebral spinal fluid (CSF) administration via i.c.v. or intrathecal (i.t.) injections.<sup>13</sup> While there are different types of toxicity associated with oligonucleotides,<sup>50,51,53</sup> CSF administration will likely impose additional limitations. CSF is a tightly balanced fluid circulating throughout the brain, and its correct composition is essential for neuronal function and signal transduction. Human CSF is composed mostly of water (99%), with a small amount of proteins, vitamins, glucose, and ions (sodium [ $\text{Na}^+$ ], potassium [ $\text{K}^+$ ], calcium [ $\text{Ca}^{2+}$ ], magnesium [ $\text{Mg}^{2+}$ ], and chloride [ $\text{Cl}^-$ ]).<sup>34</sup> Calcium is one of the vital components of CSF that is directly involved in neuronal activity.<sup>59</sup> Calcium and magnesium divalent cations play critical roles in neuronal functioning, and a reduction of either in the CSF and intracellular stores could lead to seizures.<sup>60,61</sup> Although the mechanism remains unclear, there is evidence of hypocalcemia-induced seizures in humans with pre-existing endocrinological abnormalities.<sup>62</sup> Thus, care must be taken to ensure that drugs administered directly into the CSF have CSF-compatible formulations.

The molecular mechanisms underlying dose-limiting toxicities of oligonucleotides are diverse and not fully understood. While numerous clinical trials involving ASOs in the CNS have been halted due to toxicity<sup>4,19</sup> and an inability to reach effective levels,<sup>5,63–68</sup> others have resulted in the development of disease-modifying drugs that change the lives of thousands of patients.<sup>69</sup> Moreover, it is probable that various structural and chemical classes of oligonucleotides (single-stranded, double-stranded, lipophilic conjugates, and divalent) may differ in their toxicity mechanisms. Clinical data on CSF-administered siRNAs is limited, with only one compound (ALN-APP)<sup>11</sup> reaching clinical trials and demonstrating a significant reduction in amyloid precursor protein (APP) cerebrospinal fluid biomarkers. Its efficacy was clouded, however, by reported toxicity observed in

high-dose repetitive non-human primate studies (Nature Conference 2023).

Recently, Jia et al.<sup>16</sup> reported a systematic evaluation of acutely neurotoxic ASOs with different sequence and modification patterns. They demonstrate that the molecular mechanism driving neurotoxicity in toxic ASOs is related to the reduction in intracellular Ca<sup>2+</sup> concentration in neurons, which can be mitigated by modulating Ca<sup>2+</sup> channel activity. The authors explored the impact of preformulating ASOs with Ca<sup>2+</sup> *in vivo* and observed a slight increase (~10%–15%) in observable short-term cumulative neurotoxicity. This finding contrasts with Moazami et al.<sup>20</sup> and our own reports. Their study focused on neurotoxic ASOs at concentrations significantly lower (25 vs.

225  $\mu\text{g}$ ), with observable neurotoxicity mostly limited to consciousness, motor function, and appearance rather than profound seizures and death. It is possible that other toxicity mechanisms, such as protein binding, may be contributing factors. Further systematic exploration of observable toxicity and mitigation strategies at a wide range of concentrations and formulations would be necessary to better understand the differences in reported experiments.

In our previous studies, long-term anesthesia in rodents, such as tribromoethanol (TBE, Avertin),<sup>14</sup> was sufficient to mask the short-term neurotoxicity of high doses of siRNA. After an hour, mice recovered normally and demonstrated robust efficacy with no evidence of long-term toxicity. In recent human  $n = 1$  trials, including Milasen<sup>70,71</sup> and Jacifusen,<sup>72</sup> patients were under general anesthesia and sedation for the i.t. ASO injections, which may mask the acute neurotoxicity in rodents presented here. To more closely mimic human studies, we switched to isoflurane as a light, general anesthetic, which revealed short-term neurotoxicity that had not been apparent previously. In our experiments, the optimized aCSF+ formulation effectively eliminated acute toxicity observed under general anesthesia for various di-siRNAs, including compounds targeting MSH3,<sup>73</sup> ApoE,<sup>35</sup> and others (data not shown). For double-stranded RNAs, neurotoxicity appears more dependent on the scaffold than the sequence within the tested experimental conditions.

For ASOs, both sequence and modification patterns impact the degree of observable adverse events. In this work, the HTT-targeting ASO gapmer with a mixed versus fully phosphorothioated backbone exhibited profoundly different short-term toxicity. The fully PS-modified ASO induced seizure-like adverse events similar to siRNAs, while the mixed PO/PS backbone was better tolerated, with only hyperactivity and ataxia observed. For both ASOs, the use of aCSF+ reduced the short-term toxicity. For the injection dose of 225  $\mu\text{g}/10 \mu\text{L}$  of (1 mM) di-siRNA, a 14:2 (14 mM  $\text{Ca}^{2+}$  and 2 mM  $\text{Mg}^{2+}$ ) supplementation was fully effective in reducing observable short-term seizures. For 225  $\mu\text{g}/10 \mu\text{L}$  of ASO (equivalent molar concentration of PO/PS backbones to the 225  $\mu\text{g}/10 \mu\text{L}$  of (1 mM) di-siRNA dose), aCSF+ with the same divalent cation content was effective in reducing observable short-term seizures, but the mice still experienced some other adverse events, including ataxia and extended wake-up times. These differences may be due to slight dif-

ferences in the total charge of the molecule and should be evaluated further depending on the oligonucleotide.

The other interesting difference we observed between siRNAs and ASO is the sensitivity of the short-term toxicity to PS content. PS backbone modifications increase ASO toxicity, but the direct mechanism is not well defined.<sup>74</sup> In the clinic, all gapmer ASOs have a mixed PO/PS backbone where several PS linkages are substituted with PO to reduce the observable toxicity.<sup>6,19,20</sup> Some studies have shown that PS-ASOs bind more frequently to nuclear proteins than PO-ASOs, which is associated with this toxicity.<sup>75</sup> Consistent with published data, reduction in the PS context significantly increased the short-term tolerability of the ASOs. With siRNAs, we have not seen such a profound impact correlated to the PS context. The toxicity of the siRNAs with 23% and 37% PS backbones, respectively, was similar. Although the version of di-siRNA<sup>HTT</sup> with no PS modifications (this siRNA is functionally inactive) was slightly better tolerated than the 26 mM PS modified version of di-siRNA<sup>HTT</sup> in  $1 \times$  PBS, the same concentration of divalent cations in aCSF was required to mitigate seizures and adverse events for both compounds completely. The reported PS-induced toxicity may be a secondary mechanism related to the nuclear protein binding of ASOs, whereas siRNAs do not efficiently get into the nucleus. Further studies will be required to identify and understand this mechanism of toxicity.

A different formulation may be necessary for some ASOs and siRNAs due to the profoundly different biophysical properties of the two oligonucleotide classes. ASOs are single stranded and thus amphiphilic in nature, while siRNAs are duplex, rigid, and negatively charged. Double-stranded oligonucleotides also have a higher binding capacity for divalent cations compared with single-stranded oligonucleotides.<sup>54</sup> Another potential difference is the sensitivity of the observed effects to sequences. With single-stranded ASOs, sequence significantly affects the self-structure and, thus, the degree of amphiphilicity, impacting divalent cation binding avidity. In addition, self-folding can create dimeric or aptameric-like effects, where the exact mode of interaction with ions and cells is challenging to predict. This is likely why this class of toxicity is more affected by sequence and chemical modification patterns in ASOs but not in siRNAs.<sup>76–78</sup>

To avoid the complications associated with phosphate calcium salt precipitates, we used a HEPES-based<sup>79</sup> aCSF buffer for all experiments. There is a limited number of pharmaceutical-grade buffers certified for CSF administration, with PBS being one of them. ASOs in human clinical trials have used commercial aCSF (Elliotts B solution; NDC 55792-007)<sup>44</sup> as the buffer for CSF delivery. Elliotts B solution contains phosphate and significantly lower amounts of Ca<sup>2+</sup> and Mg<sup>2+</sup> (1.35 and 1.2 mM, respectively)<sup>45</sup> than those necessary in our studies. As buffering of nucleic acids is highly desired to ensure long-term stability and consistency, the use of calcium-containing formulations in the clinic would necessitate additional optimization and likely require the use of non-phosphate-based buffering solutions.

Overall, our studies provide both an *in vivo* validation of oligonucleotide-induced neurotoxicity following i.c.v. injections in mice as well as methods to prevent such effects. The use of EEG/EMG in awake animals sets our studies apart from others in the field, as it provides quantifiable measurements of oligonucleotide-induced seizures. Divalent cations bind preferentially to the phosphate backbone of oligonucleotides, which translates to an imbalance in the ion homeostasis of the CSF following i.c.v. injections *in vivo*. Our findings demonstrate that this imbalance can be prevented when oligonucleotides are delivered with specific divalent cations in aCSF buffer. We observed that formulation in aCSF+ has no impact on functional silencing or other measurable phenotypes. Thus, in preclinical models, divalent cation-enriched buffers will simplify experiments and allow higher doses of oligonucleotides to be administered, which may enable longer duration and less frequent administration. The translation to clinic is much more complicated, and detailed studies on the toxicity and tolerability of divalent cation-enriched formulation need to be performed in large animal models and clinics. This area of research merits further exploration to understand the deeper mechanisms of ionic imbalance in the CSF and the long-term effects on brain function and neuronal survival.

## MATERIALS AND METHODS

All of the studies in this manuscript were conducted in compliance with the Institutional Care and Use Committee (IACUC) guidelines of the University of Massachusetts Chan Medical School (docket nos. 202100018 and A2574) and the University of California Davis (docket no. 22308).

### Statistics and reproducibility

Data analyses were performed using GraphPad Prism 9.0 software (GraphPad Software). Data were analyzed using a one-way or two-way ANOVA test with Bonferroni's or Tukey's test for multiple comparisons as specified in the figure legends. Differences in all datasets were considered significant at  $p < 0.05$ .

### Oligonucleotide synthesis

Oligonucleotides were synthesized by phosphoramidite solid-phase synthesis on an AKTA Oligopilot 100 (Cytiva, Marlborough, MA) with standard protocols. 5'-(E)-Vinyl tetraphosphonate (pivaloyloxy-

methyl) 2'-O-methyl-uridine 3'-CE phosphoramidite was used for the addition of 5'-vinyl phosphonate, 2'-F, 2'-OMe phosphoramidites with standard protecting groups were used to make the modified siRNAs (Hongene Biotech, Union City, CA). Phosphoramidites were dissolved at 0.1 M in anhydrous acetonitrile (ACN), with added anhydrous 15% dimethylformamide in the case of 2'-OMe-uridine amidite. 5-(Benzylthio)-1H-tetrazole (BTT) was used as the activator at 0.25 M. Coupling times were 4 min. Detritylations were performed using 3% trichloroacetic acid in dichloromethane. Capping reagents used were CAP A (20% N-methylimidazole in ACN) and CAP B (20% acetic anhydride and 30% 2,6-lutidine in ACN). Phosphite oxidation to convert to phosphate or PS was performed with 0.05 M iodine in pyridine-H<sub>2</sub>O (9:1, v/v) or 0.1 M solution of 3-[(dimethylaminomethylene)amino]-3H-1,2,4-dithiazole-5-thione (DDTT) in pyridine for 3 min, respectively. All reagents were purchased from Chemgenes (Wilmington, MA). Guide oligonucleotides were synthesized on 500 Å long-chain alkyl amine controlled pore glass functionalized with a Unylinker terminus (Chemgenes). Divalent oligonucleotides (DIOs) were synthesized on custom solid support prepared in-house.<sup>12</sup>

### Deprotection and purification of oligonucleotides

Vinyl-phosphonate-containing oligonucleotides were cleaved and deprotected with 3% diethylamine in ammonium hydroxide, for 20 h at 35°C with agitation. DIOs were cleaved and deprotected with 1:1 ammonium hydroxide and aqueous monomethylamine, for 2 h at 25°C with agitation. The controlled pore glass was subsequently filtered and rinsed with 30 mL of 5% ACN in water, solutions were evaporated overnight using a centrifugal vacuum concentrator. Purifications were performed on an Agilent 1290 Infinity II HPLC system (Agilent Technologies, Lexington, MA), using Source 15Q ion exchange resin (Cytiva). The loading solution used was 20 mM sodium acetate in 10% ACN in water, and elution solution was the loading solution with 1 M sodium bromide. A linear gradient was used from 30% to 70% for 40 min at 50°C. Peaks were monitored at 260 nm. Pure fractions were combined and desalted by size exclusion with HPLC Honeywell water (AH365) using Sephadex G-25 (Cytiva). The purity and identity of fractions and pure oligonucleotides were confirmed by IP-RP LC/MS (Agilent 6530 Accurate-mass Q-TOF LC/MS).

### Endotoxin removal of oligonucleotides

Purified oligonucleotides (<10 μmol) were processed using 50K Amicon 15 ultracentrifugal units for 25 min at 5000 rpm at room temperature until the hold-up volume was approximately 200 μL. The oligonucleotide traces in the hold-up volume were washed twice with 5 mL of ultrapure water (Apex BioResearch) using the same centrifugation parameters. The cleaned oligonucleotides were then dried under vacuum and resuspended in the appropriate buffer formulation. An aliquot was taken to measure endotoxin levels using an Endosafe Nexgen-PTS, LAL Cartridge-Based Assay (range 0.01–1.00 EU/mL), purchased from Charles River (Wilmington, MA). Endotoxin levels were within the recommended limits for CSF administration, as per published guidelines.<sup>80</sup>

### Divalent cation supplementation in aCSF buffer

Stock solutions of artificial CSF (aCSF) were prepped as follows: 1 M  $\text{CaCl}_2$ , 1 M  $\text{MgCl}_2$ , 1 M  $\text{NaCl}$ , 1 M  $\text{KCl}$ , and 100 mM D-(+)-glucose  $\text{CaCl}_2$ , all in sterile water. The stock aCSF diluent was prepped with the following final concentrations of components: 137 mM  $\text{NaCl}$ , 5 mM  $\text{KCl}$ , and 20 mM D-(+)-glucose in an 8 mM HEPES buffer base. To prepare aCSF buffers with varying ratios of divalent cations, serial dilutions of  $\text{CaCl}_2$  and  $\text{MgCl}_2$  in the stock aCSF buffer were made. Finally,  $\text{CaCl}_2$ - and  $\text{MgCl}_2$ -containing aCSF stocks were combined to make buffers containing various ratios of divalent cations. After synthesis, the siRNAs resuspended in water were duplexed and dried in a Speedvac overnight. The resulting pellets were resuspended in the necessary aCSF buffer for the injected dose.

### Duplexing of siRNAs for ion supplementation in aCSF buffer

Single strands of siRNAs were completely dried down using a SpeedVAC. Once dry, single strands were resuspended in pre-made aCSF containing  $\text{Ca}^{2+}/\text{Mg}^{2+}$ . Resuspended single-strand concentrations were measured by nanodrop, and the A260 value was used for calculation. Antisense strands were duplexed to sense strands at a 2:1 ratio by heating to 95°C for 5 min and cooling at room temperature. Duplexes were verified by running on a 20% TBE agarose gel at 180 V for 1 h. Duplex concentrations were measured by nanodrop, and the A260 was used to calculate them. Depending on the desired dose, aCSF was added to dilute as necessary.

### Ion chromatography

Small aliquots (0.2 mL) of the di-siRNAs (4 mM) in sodium form dissolved in water were mixed 1:1 with solutions of 200 mM  $\text{Ca}^{2+}$ , 200 mM  $\text{Mg}^{2+}$ , or 200 mM  $\text{Ca}^{2+}/\text{Mg}^{2+}$ , forcing exchange of the divalent cations to the bound monovalent sodium cations. Removal of the excess cations in solution not bound to the siRNAs was done with 3K centrifugal filter units (Amicon Ultra-4). siRNAs were diluted to a final volume of 4 mL with nuclease-free water and transferred to the Amicon tubes. Tubes were then centrifuged for 40 min at 5000 rpm (Wash). The wash procedure was repeated a total of three times, where each time the holdup volume (~0.1 mL) was diluted to a final 4 mL to start the next wash. The osmolality of the solution was determined after each wash to track the removal process. Osmolality was measured on a FreezePoint 6000 Osmometer (ELITechGroup, Logan, UT).

Ion chromatography was performed on a Metrohm Compact IC Flex, equipped with an autosampler and conductivity detector (Metrohm, Riverview, FL). di-siRNA (20  $\mu\text{L}$ ) was loaded into a Metrosep C4 4  $\times$  150 mm column. A 12-min isocratic eluent of 3.5 mM oxalic acid solution was used to separate the cations. A calibration curve in the linear range of 1–75 ppm of standards mix ( $\text{Li}^+$ ,  $\text{Na}^+$ ,  $\text{NH}_4^+$ ,  $\text{K}^+$ ,  $\text{Mg}^{2+}$ , and  $\text{Ca}^{2+}$ ) was used to calculate the concentration of the studied cations in the samples.

### Mouse intracranial injection surgeries

Wild-type FVB mice were purchased from The Jackson Laboratories. YAC128-HD<sup>81</sup> and BAC-CAG-HD<sup>82</sup> mice were maintained in a col-

ony as heterozygotes on an FVB background. All animals were maintained and used according to the Institutional Animal Care and Use Committee guidelines of the University of Massachusetts Chan Medical School (docket no. 20210018). In brief, mice were housed with a maximum of five per cage in a pathogen-free facility under standard conditions with access to food, water, and enrichment *ad libitum*. Mice were i.c.v. injected bilaterally directly at age 8 weeks. The mice were anesthetized under constant isoflurane flow and placed into a small animal stereotaxic apparatus (ASI Instruments and WPI Instruments). Microinjector pumps were fastened to the stereotaxic and set to deliver 5.0  $\mu\text{L}$  of the siRNA at a rate of 500 nL/min. The surgical position was set using the bregma as the zero position for guidance, then measured  $\pm$  0.8 mm medial-lateral and  $-0.2$  mm anterior-posterior, and finally lowered  $-2.5$  mm dorsal-ventral i.c.v. The injection was started 1 min after the needle was inserted, and the needle was removed 1 min after the injection was completed. Once the injection was complete, the mice were placed on a heating pad until fully awake and returned to their primary housing facility. Each animal received 0.1 cc/10 g ketofen subcutaneously once fully awake. All mice were housed individually post-op to allow healing and avoid losing stitches.

### Mouse tissue collection

The experimental endpoint for mRNA and protein analysis was 1 or 2 months post-i.c.v. injections. At the determined time point, mice were deeply anesthetized with tribromoethanol and perfused intracardially with 20 mL cold 1 $\times$  PBS buffer. The brains were cut in half; half was post-fixed in 10% formalin for 24 h and switched to 1 $\times$  PBS at 4°C for long-term storage. The other half was immediately sliced into 1.0 mm sections using a brain matrix (Kent Scientific, RBMA-200C). Brain sections floating in cold 1 $\times$  PBS were punched using 1.5 mm sterile biopsy punches. The brain punches were submerged in RNAlater or flash-frozen on dry ice and stored at  $-80^\circ\text{C}$  for mRNA and protein analysis.

### Electrophysiology in mice: Surgery

Mice were anesthetized with ketamine/xylazine (100 and 10 mg/kg, respectively, intraperitoneally [i.p.]) and then placed in a stereotaxic apparatus. Mice were implanted with a bilateral guide cannula (PlasticsOne, no. C235GS) in the lateral ventricles (coordinates from bregma are 0.0 mm antero-posterior,  $\pm 1.0$  mm lateral,  $-2.3$  mm dorsoventral, as per the mouse atlas of Paxinos and Franklin 2001).<sup>83,84</sup> The guide cannula is closed using a dummy (PlasticsOne, no. C235DCS) and secured using a dust cap (PlasticsOne, no. 303DC). The mice were also implanted with two EEG screw electrodes, one parietal (mid-distance between bregma and lambda and 1 mm lateral from the mid-line) and one on the cerebellum (6.5 mm caudal, 0 mm lateral from bregma, reference electrode) electrodes (Pinnacle Technology, cat. no. 8403) and two flexible electromyography (EMG) wire electrodes (in the neck muscles; Plastics One, cat. no. E363/76/SPC), previously soldered to a 6-pin connector (Heilind Electronics, cat. no. 853-43-006-10-001000). The whole assembly is secured to the skull with dental cement. After

completing the surgery, mice were kept in a warm environment until normal activity was resumed, as described previously.<sup>37–41</sup>

### Electrophysiology in mice: Surgery—Sleep-wake recording

Following the surgery, the mice are housed individually in transparent barrels in an insulated sound-proofed recording chamber maintained at an ambient temperature of 22°C ± 1°C and on a 12 h light/dark cycle (lights on at 07:00, zeitgeber time: ZT0) with food and water available *ad libitum*. After a minimum of 9 days for post-surgical recovery, mice are connected to flexible recording cables and habituated to the recording conditions for 5 days before starting polygraphic recording. The cortical EEG and EMG signals are amplified (A-M System 3500) and digitalized with a resolution of 256 Hz using Vital Recorder (Kissei, Japan). Video recording is synchronized to the EEG/EMG recording. Mice are recorded for a 24 h baseline period. Then, the mice received bilateral i.c.v. injection (5 µL/side, 0.5 µL/min, 10 min separating the first side injection from the second side injection). In brief, awake mice, without disconnecting the EEG/EMG cable, were gently maintained still to remove the dust cap and the dummy from the guide cannula and insert the injector system (PlasticsOne, no. C235IS) previously connected to a 40-cm-long tubing connector (PlasticsOne, no. C232C), itself connected to two Hamilton syringes (5 µL each). The mice were then placed back in the home cage and freely moved during the entire injection period. Ten minutes after completion of the bilateral i.c.v. injection, the mice were again gently maintained still in order to remove the injector system and insert the dummy and the dust cap back in. EEG/EMG signals were recorded for 24 h following the end of the i.c.v. injection. The mice were then deeply anesthetized (ketamine/xylazine 200 and 20 mg/kg, respectively, i.p.) and injected i.c.v. with a blue dye (0.5–1 µL), and the brain was dissected to control for guide cannula correct placement in the lateral ventricles (Figure S2). Mice with incorrect guide cannula placement were removed from the study.

### Electrophysiology in mice: EEG/EMG analysis

Using SleepSign for Animal (Kissei, Japan) assisted by spectral analysis using FFT, polygraphic records are visually inspected for high amplitude EEG/EMG waves characteristic of seizures. Seizures were defined as periods with high frequency and high amplitude with a minimum duration of 5 s. Seizures were identified visually from EEG/EMG signals, and videos were checked to determine if there was a behavioral accompaniment.

### Htt mRNA silencing quantification

Brain tissue punches were incubated in RNAlater overnight and then stored at –80°C. The punches were lysed in 600 µL Quantigene homogenizing solution (Thermo Fisher Scientific, cat. no. QS0518) with 6 µL 20 mg/mL proteinase K solution (Thermo Fisher Scientific, cat. no. AM2546) with sterile beads on a tissue lyser (Quantigene, cat. no. 9003240). The lysates were spun down at 2,000 × g and incubated at 55°C for 30 min. The lysates were transferred to deep well plates and stored at –80°C. On the day of analysis, brain lysates were incubated at 55°C until thawed (approximately 30 min). The Quantigene manufacturer's protocol was followed for the Singleplex Gene Expression

Assay (Thermo Fisher Scientific, cat. no. QS0016), as previously published.<sup>36</sup> Wild-type mouse *Htt* mRNA (probe SB-14150) and human *HTT* mRNA (probe SB-50339) levels were measured and normalized to mouse HPRT mRNA (probe SB-15463). The background signal was subtracted, and all reads were normalized to non-injected controls.

### HTT protein silencing quantification by ProteinSimple (Wes)

Frozen tissue punches were homogenized on ice in 75 µL 10 mM HEPES (pH 7.2), 250 mM sucrose, 1 mM EDTA + protease inhibitor tablet (Roche) + 1 mM NaF + 1 mM Na<sub>3</sub>VO<sub>4</sub>, sonicated for 10 s, and protein concentration determined by Bradford assay (BioRad). The standard settings for the 66–440 kDa separation modules were used with 0.2 mg/mL of each lysate and anti-HTT (Ab1,<sup>85</sup> 1:50) plus anti-vinculin (Sigma, 1:2,000) antibodies. The peak area was determined using Compass for SW software (ProteinSimple) and dropped line-fitted peaks.
