## Chapter One

### Introduction

The primary intent of this document and accompanying database is to provide electronic access to articles contained in GIS proceedings and book compendiums. At present, searching for such articles is typically done manually. If users find this document worthwhile, new editions are likely to be provided on a yearly basis.

#### 1.1 Electronic Access to GIS Articles in Journals

Finding GIS articles in journals through electronic searches is now relatively straight-forward in most university libraries in the United States. Private database vendors such as *STN*, *Dialog*, *BRS* and *Wilsonline* offer online access and searching capabilities (for a fee) to hundreds of bibliographic databases incorporating thousands of journal titles. Similarly, consortiums of universities and research groups have pooled their resources to offer bibliographic searching capabilities to their members. Examples of such databases include *CARL uncover* (Colorado Alliance of Research Libraries) which any university may subscribe to and *MELVYL* (University of California System) which is available only to consortium members.

Chapter Two lists journal titles which may be of interest to GIS researchers. Databases through which the journals may be accessed and searched are indicated. If you need help in using the databases, consult your university reference librarian for a quick lesson.

#### 1.2 Electronic Access to GIS Articles in Conference Proceedings

Proceedings articles are the "gray literature" of most academic disciplines. Although the quality of proceedings articles is seldom controlled, proceedings articles form an important literature base. Conferences provide opportunities to present and explore new ideas, unproven concepts, and practical experiences. This type of material is often unacceptable for inclusion in refereed journal articles. Conferences also allow investigators to report research progress and preliminary findings in order to receive feedback from peers as their work progresses.

Unfortunately, GIS conference proceeding articles are only sporadically covered by the current online database services. Similarly, GIS books which contain articles or chapters written by different authors are difficult to access by the titles and authors of those chapters. The primary purpose of this document and accompanying data base is to provide bibliographic citations for all articles contained in the major GIS conference proceedings and book compendiums for the previous year.

The accompanying database may be used with desktop bibliographic software such as *EndNote Plus*, *Pro-Cite* or *BibIX/Refer(Unix)* to carry out various types of searches and to aid automatic generation of subject bibliographies. From a practical perspective, only authors, dates, and words in titles may be searched because neither key words nor abstracts have been entered into the database. As an alternative, the database may be printed and used as a straight-forward table of contents for the proceedings volumes listed. In that instance, the word search capabilities provided by many word processing programs may be of some value in searching for items of interest.

For those unable to acquire the database through anonymous ftp, a hardcopy titled "NCGIA Annual GIS Bibliography for 1992" may be obtained for a nominal price from NCGIA. A 3.5 inch disk containing the same files as available at the ftp site is supplied with each hardcopy.

### **1.3 Acquiring Copies of the Database through Anonymous FTP**

The GIS Bibliography for 1992 can be accessed through anonymous ftp at [ncgia.ucsb.edu](ftp://ncgia.ucsb.edu) (128.111.254.105). For those unfamiliar with the use of ftp, a short set of instructions is provided at the end of this section which should work for most systems that support ftp.

The bibliography is contained in five different files for the convenience of different users.

- GIS92.HQX
- GIS92.PROCITE
- GIS92.REFER
- GIS92.PS
- GIS92.TXT

The first three files are contained in the subdirectory **pubs / biblio / 1992**. The GIS92.HQX file is an *Endnote Plus* document in compressed binary form. This file must be "Unstuffed" using "Stuffit" software before being used directly in *Endnote* software on a MacIntosh. The "GIS92.PROCITE" file uses the *Pro-Cite* import/export format. The "GIS92.REFER" file uses the *Refer/BibIX* import/export format. These two files may be used on any platform (i.e DOS, MacIntosh, or UNIX) with *EndNote*, *EndNote Plus*, or any other bibliographic software packages that accept these formats.

For those who don't have desk top bibliography software, citations can also be accessed through postscript or ASCII formats. "GIS92.PS" and "GIS92.TXT" were created using the MLA bibliographic style and export function in *EndNote Plus*. These files are contained, respectively, in the following subdirectories: **pubs / biblio / postscript** and **pubs / biblio / text**. Whereas the first three files listed above contain only citations, these two files contain the accompanying written text (what you are now reading) and are therefore more appropriate for use if you want a finished hardcopy printout of the entire GIS Bibliography for 1992.

Detailed Instructions for Accessing Anonymous FTP [ncgia.ucsb.edu](http://ncgia.ucsb.edu) (128.111.254.105)

Get out of mail and type: `ftp ncgia.ucsb.edu`  
 ( If you are on VMS, an FTP prompt will appear. Type: user)  
 At the user name prompt, type: `anonymous` (must be lower case)  
 (If you are on VMS, anonymous must be in quotes. You will then receive a USER ACCT prompt, just hit ENTER.)  
 At the password prompt enter your login id to let us know who you are (example: `Smith@mecan1.maine.edu`) but the system will accept anything.  
 At the FTP prompt, type: `cd pub`

(If on VMS, "pub" must be in quotes.)

To see current files in the on-line NCGIA publications directory, type: dir In this directory you will see a subdirectory titled biblio as well as several others.

At the FTP prompt, type: cd biblio

(If on VMS, the sub directory name must be in quotes.)

Type again: dir You will now see subdirectories listed such as: 1992, postscript, and text.

If you want files suitable for manipulation with your bibliographic software, choose the "1992" subdirectory. If you want a copy of the bibliography suitable for hardcopy printout, choose either the "postscript" or "text" subdirectory depending on the format you desire.

At the FTP prompt, (presuming you want a copy suitable for hardcopy printout), type: cd text (If on VMS, the sub directory name must be in quotes.)

Next, type: dir Note that GIS92.txt may be one of several files currently in the subdirectory.

Presuming you wish to acquire this particular file, type: get GIS92.txt XXX.XXX (i.e. Name the file whatever you want to call it on your local system. For example, replace the Xs with: GIS.BIB) (If on VMS, GIS92.txt must be in quotes.)

Type: quit

NOTE: If before typing quit you wish to return to a higher level directory, type: cd .. (If on VMS, it must be cd "..")

The file containing the bibliography is now on your local system.

You may note that the NCGIA GIS Bibliography for 1991 is also on the server. All NCGIA on-line publications and datasets are also automatically accessible through the WAIS system (Wide Area Information Servers).

#### 1.4 Technical Issues, Disclaimers and Limitations

Citations were scanned from the original table of contents of proceedings and other volumes using a *MacIntosh* computer and scanner with *OMNI Page* software. They were then edited and spell checked using *MS Word 5*, formatted in the Refer/BibIX format, and imported to *EndNote Plus*. A final editing was done in *EndNote Plus* and files were exported as noted above. Since the citations were scanned, they are in the same configuration as the original documents. That is, if the original citation was all capitals, so is the final citation. Likewise, citations to non-English articles are in the language of the article. All name spelling checks were done manually against the original documents. All citations were made using the "proceedings" or "book section" formats in *EndNote Plus*.

This document and accompanying database were prepared for the internal use of NCGIA researchers and may or may not be suitable for some purpose you intend. Although we have tried to list titles accurately, we make no guarantees, implied or otherwise, that the titles are accurate or comprehensive. We claim no rights in the factual list of article titles and encourage its free dissemination in digital form for academic purposes.

Mention of commercial product names in this document should not in any way be construed as endorsements of those products by NCGIA or the University of Maine.

## Chapter Two

### Electronic Access to GIS Articles in Journals

The following is a list of some of the journals which GIS researchers have found useful. The list is only illustrative, not comprehensive. Designators by each title indicate some of the electronic databases through which the journals may be accessed.

The second table provides a legend for the designators in the first table and indicates some of the vendors through which the databases may be accessed. When digital abstracts are available for a journal, Dialog, BRS and STN provide them. Wilsonline databases do not. The databases listed may be accessed from most major university libraries and perhaps from your own office.
