

Fall Drug Talks End on "Bad Trip"

Mr. Dynamite, Ike and Tina Turner, the Temptations and Smokey Robinson and the Miracles didn't make it to the Legal Forum this month, baby, but in their stead they sent Dr. Sidney "Get on up" Cohen, Reverend Ross Greek-disciple of Miraculous Mother Marlow and Attorney Marvin Cahn, the Protector. So come on little darlin', and don't letta tear fall fromah your eye. . . .

Dr. Cohen, whose research interest in psychedellic drugs -genotype psychopharmacology-dates back fifteen years, spoke on what he terms taboo drugs and taboo drug behavior and directed his remarks primarily to an elucidation of the heroin and LSD scenes.

Drug-dependence of the morphine type (heroin addiction renamed by W.H.O.) according to Dr. Cohen is a \$50 a day struggle for survival. The intense craving for smack, which doesn't give the addict

much of a high but does provide a release of tensions and relief from substantial withdrawal effects, often turns the addict to prostitution, thievery, anything, and laws punishing such anti-social behavior are ineffective.

The nature of the addiction is such, states Dr. Cohen, that our efforts to legislate taboo drugs and taboo drug behavior out of existence had met with varying degrees of failure, and Synanon-type facilities are perhaps the only way to help the dependent drug user. Pharmacologically Speaking

LSD, the most widely used psychedellic drug, induces complex time-space changes and produces profound alterations of perceptoin, feeling, thinking, awareness of self. Pharmacologically speaking, it is a

hallucigen as is DMT, mescalin, STP. Hashish and marijuana are also members of that group although consid-

SBA

Referendum Set Dec. 5

SBA president Terry Timmins has announced that the law school will hold a student referendum on December 5. The subject matter of this referendum will be ten topics which the SBA Executive Board and its Election Committee selected as being of some importance to the general student body of the law school. The SBA Executive Board has mailed to the students a ballot which is to be filled out and returned to the law school on election day.

The issues raised by the referendum range in scope from questions of the proper expenditures of SBA funds to the nature and character of the activities in which the SBA should be involved. For example, the referendum seeks to find out if the student body approves of membership in such organizations as the law students' division of the ABA; and whether it should continue its participation in the Californa Conference of Law Schools.

Profundities

There are questions which are not concerned with the conduct of SBA affairs so much as an interest in an expression of student opinion on subjects of some moment to profound thinking law students, e.g. "Should an area be set aside in the Law Library

where smoking will be permitted?"

The topic which created the biggest stir among members of the SBA executive board is question ten. It seemed that many members of the board could not agree on the importance or relevance of this issue. Moreover the precise phrasing of that question became the subject for debate at a few of the recent SBA meetings. Apparently, however its present character is acceptable to all parties.

SBA president Terry Timmins has viewed this referendum as the fulfillment of a promise which he made during his campaign last spring. He hopes that this referendum will serve to spark renewed interest in the affairs of the law school, and hopefully remove some of the lethargy which he believes is all too prevalent hereabouts.

President Timmins said that he did not think it possible to hold a general discussion of these issues because of the rising pressure of final exams which will follow soon after the referendum. However, he did announce that the SBA bulletin boards are available for anyone who might care to comment on the issues presented in the referendum, or the character of the referen-

Revised Honor Code On Tuesday's Ballot

A revised "Honor Code" will be presented to the student body for approval as part of the upcoming student referendum. The revised code is designed to remedy the procedural defects of the present code. The code was revised in order to guarantee "basic due process" to an accused student and to spell out the procedural machinery for those who have to work with it. The revision also attempts to insure student participation in the determination of standards of student conduct and in the enforcement of these standards.

Throughout the 1966-67 school year a faculty-student committee negotiated as to what the revised code should provide. A draft was submitted late in the spring quarter; this draft has been further revised this quarter and is now ready for a student vote. The name "Honor Code" is subject to criticism, but it serves to effectively emphasize the underlying basis of a students enforcement system, personal honesty. Without reliance on personal honesty it would be impossible to effectuate a stu-

dent enforcement code, (the term "personal honesty" is admittedly elusive of definition, but it is descriptive as a term of art)

Limited Scope

by the general university charter to activities related to the law school . . . In order to avoid confusion as to whether a questioned activity is or is not subject to the code, an attempt was made to specifically describe the activities covered by the code.

To assure smooth handling of problems, the procedural processes are set out in detail. However, the most important reform involves the basic nature of the system. Under the revised code, a student is guaranteed basic due process rights, such as representation, confrontation by his accusor, and a "fair hearing" of the charges against him. It is hoped that the hearing will be by an impartial trier of fact; however, in a closed community such as a law school this cannot be guaranteed by the structure of the system. But the proposed system does give

Swedish Labor Law Expert

UCLA law school is proud to have a visiting scholar, for the fall quarter, Professor Folke Schmidt, who holds a chair of private law in the Faculty of Law at the Uni-



versity of Stockholm. Prof Schmidt graduated from Upsala University in 1931 and held a clerkship at a district court in Sweden until he took up the academic garb.

For the last fifteen years Prof Schmidt has focused his

lations. It is in this capacity that he has joined us at UCLA. He presently holds the newly-created Chair of Labor Law at the University of Stockholm.

Prof Schmidt is the editor of the journal, Scandinavian Studies in Law, which presents present Scandinavian legal writings to English-speaking scholars. He is currently working with Prof Benjamin Aaron and four other legal experts, K. W. Wedderburn of the London School of Economics, Gino Giugni of the University of Bari, Italy, Thilo Ramm of Giessen University, Germany, and Xavier Blanc, Jouvan. Universite d'Aix-en-Provence, France, on a monograph which they hope will be helpful for American arbitrators. The purpose of this monograph is to increase the interest, scope and effectiveness of International Labor Law.

European Law Students When asked to compare the

research talents on labor re- UCLA law school to that of Stockholm, Prof Schmidt first noted that our law students and professors maintain a friendly attitude. He also stated that there is a greater faculty-student contact here, especially in favor of the first and second year students. However, he said, the third year and graduate students receive about the same attention at both schools.

Prof Schmidt was pleased to point out that the University of Stockholm does offer a program for degrees in International and Comparative Law for the English-speaking student. Additionally, American students who already have a law degree may receive an advanced law degree from Stockholm within one year.

Prof Schmidt extends a cordial invitation to all UCLA law students to visit his office if they are interested in pursung graduate studies in law at the University of Stockholm.

The Plight of the SBA

The Student Bar Association confronts the big problem of all student governments—it has little clear authority. Despite protests to the contrary, the last word in most controversies rests with the school. Student government runs most often without enthusiastic student support. Whatever it accomplishes is more or less extracted from a neutral or reluctant student body and faculty.

It has no permanent staff; its officers never have more than two years' experience when they begin; its programs are like totally new programs each year. Recognition for its efforts is small, and more important, its officers are properly more concerned with being students than with being governors.

Accordingly, the success of the Student Bar Association is to be found in its ability to assert itself effectively in an atmosphere where no student government at all would pass relatively unnoticed. It is to the credit of this year's Student Bar that its influence has been productive on a number of occasions.

It has produced a student referendum upon which we will soon voice our opinions on administration and curriculum. It has moved to make sure that Thursday noon is free for student activities like Legal Forum. It has run another meaningful orientation for first year students, poured beer for an informal student-faculty beer bust, and arranged the successful student-faculty picnic.

If these are modest accomplishments, it is because the Student Bar is a modest government, but somewhere in the measure of a school's worth is the quality of its student government, and the Docket feels that the Student Bar is a creative rather than just neutral force in the measurement.

ered narcotics under the Harrison Act. (When asked, why is
marijuana a narcotic? What is
so dangerous about marijuana? one wonders why Dr.
Cohen and others renowned
in the field evade the issue by
saying, "We haven't done
enough research..." He
may not be in a cold sweat
about it but some people think
it's time to stop playing
games).

Visual intensification, euphoria and spectacular mental transfer of the LSD experience may also obliterate the self that a psychological deathrebirth experience could ensue which might motivate an individual to change his life patterns or which might lead to a freak out; a model psychotic state. LSD is a dangerous drug and according to Dr. Cohen, even the Yogans and Zenists were wise to the fact that only highly selected individuals should be introduced to the ultimate mysteries.

In contrast to taboo drugs and taboo drug behavior, Dr. Cohen turned to a discussion of alcohol whose use is culturally and legally acceptable, punishable only when misused or abused. "The reason we are more permissive of neutral spirits," decides Dr. Cohen, "stems from the fact that it is an intrinsic part of our culture and has been for millenium."

Sorry, Doctor. With due regard to Dr. Cohen's insistence on the rationality of man, "If our species has any claim to distinction it is . . . man's ability to be aware of his own awareness, to plan, to think logically . . . ," one cannot say that the reason alcohol is acceptable is because it has been accepted and expect that to be enough.

New Code Proposals

a much greater assurance of impartiality than does the present system.


Under the proposed code the prosecuting function is separated from the fact finding and decision making functions. These functions are performed by one body under the present system, and this is the most obvious defect of the present system. It is proposed that two separate groups perform these functions, because if these functions are not separated, no guarantee of impartiality can be made.

Rights of Defendant

Among the changes in the system is the addition of a right to confront a student suspected of violating the code. A student under the present code is required to turn in suspected violations, otherwise he is quilty of a violation. There are no provisions to explain how these failures to report are to be discovered, so they must be self-punishing.

The proposed code allows a student to request an explanation from the suspect; if satisfied by the explanation, he can stop, if not satisfied he would be required to report his suspicions. This tones down the severity of the present provision and is more practical; a student not satisfied by an explanation would be more likely to report a violation.

The proposed enforcement system is much fairer and more practical than the present system. The proposed Honor Code as a whole is ideally and procedurally a vast improvement over the present

with shouts of "Help, they're taking me away!" discussed the current marijuana laws in California, which makes it a felony for possession and use and a mandatory five year term for smuggling be it one reefer or 100 kilos. Mr. Cahn finds them to be "bad" laws and states that only the sex laws of the state are in a worse state of affairs. Mr. Cahn has no doubts that there will be a change in the law regarding marijuana—he suggests that we might end up with laws similar to the liquor control laws which are fairly effective.

Marijuana Laws

Mr. Cahn, experienced in marijuana prosecutions (30% of felony arraignments in L.A. County are for marijuana), has found law enforcement in respect to such prosecutions wanting. In many areas of the State, Orange County for example, the police are unfamiliar with the search and seizure laws. Also, in most areas, police training is wrong and police reports are often incorrect due to the law's vested interest

in discouraging publicly the use of drugs.

The reports are often geared to get high bail for offenders and to make the marijuana trade appear very profitable. Mr. Cahn believes that many narcotics officers are emotionally motivated people who see drug users as being that which is anti-establishment and a

threat to them. The way to win cases, says The Protector, is to investigate and be up on the latest laws. I hope his number is in the book.

The Legal Forum presented between Reverend Ross Greek and Mr. Marvin Cahn a panel discussion on the Role of the Lawyer. It attracted a large


