Quick hits The CASE Act and effects on libraries

- Copyright Alternative in Small-Claims Enforcement (CASE) Act
- Copyright Claims Board (CCB) to hear smaller \$ infringement claims
- individual opt out (60 days), federal & state exempted, libraries & archives can opt out permanently
- advocacy & education for our higher ed communities

Quick hits Controlled digital lending and the **Internet Archive** lawsuit

- Libraries make digital copies of physical works held in their collections available to users
- 1:1 "own to loan", TPM to prevent copying, limited time of lend, etc.
- During Covid pandemic, HathiTrust ETAS
- Publisher lawsuit against IA's Open Library & National Emergency Library
- Other libraries continued & expanded CDL services

Quick hits Intersection of copyright and contracts

- Faculty, students, researchers leverage fair use in scholarship
- Licensed resources can trump fair uses through unfriendly TOS
- Library licensed resources and fair use savings clauses
- Copyright preemption: ML
 Genius v. Google

Quick hits Copyright and text data mining, artificial intelligence, etc.

- Fair use to compile corpus to conduct text data mining (Authors Guild v. Google, Authors Guild v. HathiTrust)
- But not necessarily fair to republish the underlying corpus
- Now: lawsuits on Al image creation tools
- USCO refuses to register © in Al-generated images
- What's the future of © and AI?
