EXAMS ARE COMING

In case you hadn't noticed, this is the last week of classes; procrastination time is over. Here is some useful info.

LAST DAY TO DROP CLASSES will be Friday, March 11, provided that a takehome exam has not been given out prior to that time, and provided that you do not go below residency requirements. (It would be rational to have the pass/fail option at this time but we don't - yet).

DISTRIBUTION WINDOW WILL CLOSE on Thursday, March 10, after working it's normal hours for that day. It will open again next quarter.

EXAM NUMBERS are expected to be available at the Records Office Window on Tuesday, March 8.

BUY YOUR OWN BLUEBOOKS. Efforts by the SBA to have the practice of the law school of providing bluebooks continue have failed so far, so students must once again provide their own bluebooks for exams.

POSTPONEMENT OF EXAMS AND PAPERS.

The Academic Rules state in part:

"If, at any time, a student is the victim of disabling circumstances and feels that he/she cannot perform adequately in class work, course papers, and/or examinations, he/she must bring this to the attention of the Assistant Dean for Student Affairs when the problem occurs and consult with him about the possibility of postponing examinations or course papers, withdrawing in good standing, and depending on the circumstances, other alternatives. Students with such problems should not gamble on taking examinations or completing course papers and then expect to gain readmission or other relief if they fail. Only official authorization for relief in these circumstances can maintain a student's good standing."

() added. There is lots of good stuff in the rules, check them out. By the way, asking your professor to give you a later exam may be a violation of the anonymous grading system; talk to Dean Slaughter.
