NATIONAL MOOT COURT HONORS COMPETITION

On Thursday evening, Nov. 17, Mike Josephson, Rick Millar, and Jay Bulmash competed in the first round of the National Moot Court Honors Competition against Willamette School of Law in Oregon.

The case argued was a case challenging the constitutionality of a statute permitting police eavesdropping. The statute did not explicitly deal with whether the police can trespass to plant a "bug". In the case, the police picked the lock of the defendant's office and the "bug" remained for fourteen days.
