# ABSTRACT

We describe the design of Story Builder, a tool to support adolescents in building interactive multimedia stories that integrate data analysis and visualization with text, images, and other multimodal resources. Story Builder is a plug in for the Common Online Data Analysis Platform (CODAP), a free, online, open-source drag-anddrop interactive data analysis system. Based on early prototyping conducted with several 7th grade classrooms, we sought to design a tool that would allow students to (a) integrate their data investigations with relevant personal and contextual information; (b) record the step-by-step process and rationale of their data analysis; and (c)

reflect on and share these contextual and process-oriented elements of data analysis work with others. A major goal of Story Builder is to encourage students to consider and incorporate personal, social, and scientific considerations during data analysis.

## 1 INTRODUCTION

118 There is growing interest in integrating data literacy and data sci-119 ence throughout the K-12 curriculum [6, 8, 15]. One practice that is 120 increasingly common in the professional world, and is generating 121 enthusiasm from educators, is *data storytelling* [19]. In data storytelling, the presentation of data and statistics are coupled with 123 other visual and narrative elements to explain what is done to data 124 during the process of analysis, why such analysis is important, and 125 to communicate to a broad audience the results and implications of 126 said analysis.

127 The Writing Data Stories project (NSF IIS-1900606) seeks to intro-128 duce students to data storytelling by encouraging them to articulate 129 their personal and social connections to data as they simultaneously 130 engage with the statistical patterns contained therein. In doing so, 131 our project recognizes that a great deal of conceptual and personal 132 work goes into students' initial preparation and exploration of data. 133 For example, students may seek a grounding in the data by filtering 134 and searching a dataset to find specific records that represent them-135 selves or other familiar information [18, 21]. Or, they might want to 136 reduce the complexity of their initial investigation by focusing on 137 only a few key attributes of a large dataset, expanding their investi-138 gation later [7]. These decisions are not merely about "preparing" 139 or "cleaning" data, but also represent some of the ways that stu-140 dents build relationships to data and leverage their background 141 knowledge to drive exploration [12, 17, 22]. However, it is difficult 142 to capture these process-oriented aspects of data work in most 143 spreadsheet or exploratory visual data tools. The Story Builder tool 144 allows students to capture and reflect on snapshots or "moments" 145 of their process as they transform, analyze, visualize, interpret, and 146 communicate the results of large-scale scientific datasets. We have 147 been developing and testing the Story Builder tool to support stu-148 dent investigations related to socioscientific topics including health, 149 climate, and local ecosystems. 150

## 2 THEORY AND RELATED WORK

The Writing Data Stories project, and the design of Story Builder specifically, are inspired by literature in both science and statistics education that emphasize the need to introduce students to data as evidentiary texts. The science education literature, for instance, has demonstrated that it is important for students to understand how data can be made useful for the needs that arise in their own course of investigation, rather than for a predetermined goal [16]. While much research has explored how this can be done by having students collect their own data, less has explored how students might approach large, pre-existing datasets as resources that they can re-construct and re-represent for purposes of analysis. However, working with such large existing datasets is central to science practice [5]. When working with externally-sourced data, practitioners must decide whether those data are relevant to their questions, and what types of changes, visualizations, or reorganizations are required to make them useful [13].

This transformation and visualization of datasets through can be thought of as the reading and writing of data in new ways that communicate particular investigations and findings. This treatment of data is consistent with research that has explored the use of provided datasets in statistics education, as a means to develop 175

learners' capacities to engage in what Tukey called exploratory data analysis [20]. Most such work, suggests it is important to emphasize provided data not as a static resource but rather something to learn from [3] and use in argument [2]. It is also consistent with what Duschl refers to as transitional practices of science, encoded and communicated through "data texts" that describe how evidence is turned into explanations (including through data manipulation; p. 208) [4]. Importantly, this involves having students explicitly reflect on their work with data including how data were generated, their processes of analysis, their predictions, and their interpretations [14].

Importantly, Story Builder is intended to support a more integrative and intentional weaving of students' personal contexts with scientific and mathematical study. This approach is consistent with the constructionist tradition within the child-computer interaction literature, which highlights the importance of perspective and meaning-making in learning with digital tools [1, 11]. We further complement this interest in the *personal* with an interest in the *social*, particularly the historical and political contexts in which socio-scientific issues unfold. Drawing from interdisciplinary theories of literacy development, particularly among marginalized youth [10], one goal of integrating the personal, social, and scientific is to expose and make available for analysis the tensions between formal and informal discourses as a means to interrogate power.

## **3 THE DESIGN OF STORY BUILDER**

Story Builder seeks to support students in approaching data as a *text* and a *source of argumentative evidence* by providing an infrastructure for students to (a) integrate their data investigations with relevant motivational and contextual information; (b) record the step-by-step process and rationale of their data analysis; and (c) reflect on and share these contextual and process-oriented elements of data analysis work with others. It is a plug-in for the Common Online Data Analysis Platform (CODAP; accessible at codap.concord.org), a free, online, drag-and-drop data analysis and visualization tool designed for novice data analysts from early adolescence into their early college years. We begin this section by providing a brief description of the CODAP platform, then describing the specific features of the Story Builder tool; a more complete and detailed description of CODAP's features can be found in [9].

# 3.1 The Common Online Data Analysis Platform (CODAP)

CODAP allows users to load one or more datasets by dragging and dropping any CSV data file onto the screen to create a "CODAP Document". A dataset can be viewed as a table, or or as a stack of "case cards" that describe each record as if it were written on an individual index card (Figure 2).

Once a dataset is loaded, young analysts can add one or more scatterplots or maps to the document to visualize and explore their data. When a scatterplot is first added, it displays dots (each representing a record in the dataset) scattered randomly in the graph space. They can organize the plot into a visualization of their data by dragging and dropping attributes (column names) from the dataset onto the axis they would like to appear. Scatterplots can

also include statistical overlays that provide visual indicators of, for instance, the mean, median, or line of best fit for a given set of data, depending on how those data are visualized. If a dataset includes geographic information, students can also create maps and drag-and-drop attributes to colorize the map accordingly. When one or more records in a dataset are selected, the corresponding visual representations of that record are also highlighted to allow for analysis across visualizations (Figure 3).

CODAP also allows students to transform their data using any number of well-known data transformation actions such as calculating new variables, grouping data hierarchically, filtering or sorting their dataset, and more [7]. As they work, students can save their "document" as a particular arrangement of windows including the dataset, graphs, maps, and other elements. This functionality is similar to an Excel spreadsheet where the final state of the spreadsheet can be saved and re-opened, but all elements of the document remain interactive and can be further manipulated.

### 3.2 Story Elements

Earlier versions of CODAP without Story Builder allowed for a limited number of other multimodal elements to be added to a

document including web pages, images, and text. As we developed Story Builder and consulted with learners, designers, and educators, we have expanded the type and richness of elements that can be added to better support fully multi-modal storytelling. This includes more robust support for adding and resizing images, adding a rich text editor, and introducing the capability to add video and audio recordings as CODAP elements. Each story element appears in a window that can be moved, resized, and even stacked over other windows on the screen.

#### 3.3 The Moments Bar

The core innovation behind Story Builder is that it introduces a temporal dimension to a CODAP document so that students' work with data can be captured, edited, and retold as a series of "moments." Moments can be thought of as snapshots of a CODAP document as students move through their analysis process. As students conduct data investigations, their moments may capture and allow them to reflect upon, explain, and share actions such as transforming data; adding, deleting, or moving elements on the screen; creating and revising graphs and maps to discover new relationships; and developing media and text explanations of their motivations, decisions, and interpretations. They preserve the identity of particular windows over time, so that as windows are moved around on the screen, made smaller or larger, or moved to the foreground or background, these actions are animated to document the flow and continuity of analysis. Students can put moments into a preferred order using a drag and drop "Moments Bar" in order to construct a narrative that brings together these motivations, decisions, findings, and interpretations (Figure 4).

Because moments capture a variety of changes ranging from adjusting the location of elements to significant transformations of data, there is a great deal of flexibility in how a Data Story unfolds. Once students are satisfied with their data story, they can "lock" the moments bar and make their CODAP document available to others as a standard CODAP file. Locking a Data Story allows viewers of the document to click through and interact with each moment, without editing or overwriting any of the saved work done by the original author. All of the data, visualizations, and other media in Story Builder are still interactive after they are captured in a moment, even when the story is locked. This allows others who are reading a peer's data story to engage first hand with the data and claims contained therein.

#### **4 ONGOING EVALUATION AND EXAMPLES**

The Story Builder design is based on preliminary research we conducted with 7th grade students in several science classes in a public school that served high proportions of Latinx and emerging multilingual students in a working class suburb of the U. S. state of California during Fall 2019 and Spring 2020.

During that study, we piloted two units in collaboration with the classroom teacher. Importantly, the very foci of these units, and the datasets selected for each, were identified by the teacher who had developed her instruction for the year around the themes of diabetes and climate change. We collected student written and digital artifacts from all consented students, and video recorded

instruction from the back of the classroom. We also collected additional audio and/or video recordings of daily activities from 2-4 focal groups per classroom (a total of 11 student groups). We also collected screen recordings of all focal group interactions with the CODAP tool.

In the first unit, students explored a dataset consisting of commercial cereals and interrogated the extent to which the dataset (and common narratives and advertisements about breakfast in the United States) did or did not reflect their actual breakfast concerns and choices. The datasets included information from over 70 popular cereals' nutrition labels, and students also analyzed commercials and other marketing materials for several of the featured cereals. Part of the motivation for this focus was to allow students to bring in knowledge from prior lessons about the impact of the sugar lobby, economic access, and marketing techniques (such as the manipulation of serving size to make cereals appear healthier) on consumers' food choices. Students then added new records to the dataset to represent their own home breakfasts, as well as variables in the dataset that mattered to them (such as taste or price) before analyzing the data to justify their selection of a healthy and accessible breakfast choice.

In the second unit, students explored patterns of climate change. They began this investigation by identifying personal "special places" anywhere in the world, and exploring how those places may have already been impacted by climate and extreme weather events through news stories and web search. Examples of students' selected "special places" included parents' and families' countries of origin, homes of family members, favorite vacation spots, or places students would like to visit some day. The unit was disrupted by COVID-19 shelter-in-place orders, however, the intention was that students would then locate their special places within a global dataset, and begin to compare carbon emissions and climate indicators among the countries where those special places are located within their own student groups. Through this personal investigation, students would then be supported in eventually expanding to global comparisons in order to evaluate the inequitable distribution of who is most responsible (via emission of carbon and other greenhouse gases) and most vulnerable (due to temperature anomalies and poverty) to climate change.

## 4.1 Initial Prototyping of Story Building Activities

Our current version of Story Builder is informed by early data storytelling activities on paper, in digital Google Documents, and using the standard version of CODAP. These activities included interviews with peers about the data analysis process, open-ended stories about special places and other connections to datasets and the issues they represent, and daily observations of students as they conducted analyses using CODAP and worked to justify and record their process. Together, these observations identified what supports would be necessary for students to develop narrative accounts of their data explorations. In particular, we recognized the need for the following features, which have been incorporated into the current version of the Story Builder plugin:

• Rich text that encourages and supported student explanations for conclusions drawn from data;

- Multi-media elements that encourage personalization of data stories;
- "Replay-ability" so that students could refine and continue to interact with data and patterns identified during particular moments during their analysis process.

### 4.2 Model Data Stories

We are developing a suite of example Data Stories using the current version of Story Builder to be used as models for youth. We are seeking to support a diversity of story types (in terms of modality, scope of analysis, and topic) that all illustrate the blending of personal experience/perspective; social issues; and principled analysis and presentation of patterns data. For example, the story featured in Figure 1 documents the impact of the COVID-19 pandemic on coauthor and undergraduate research assistant Damaris Hernandez's family. It uses these experiences to motivate an exploration of the disproportionate impact of COVID on Latinx families in California.

Other example data stories unpack the close analysis of only one dataset, with a focus on process. For instance, the data story featured in Figure 4 begins with an in-depth exploration of the impact of warming temperatures on the country of Lebanon. It then uses different data story moments to compare  $CO^2$  emissions of people in countries with low poverty rates versus those in countries with high poverty rates using the same graphs highlighted differently.

## 4.3 Ongoing User Testing

We are currently beginning to test Story Builder with adolescent youth ages 10-14. We also look forward to using this tool during a series of workshops this summer that explore local datasets related to environmental justice issues including pollution, health, industry, race, and class.
